

# INTRODUCTION

## **REVIEW OF ZONING PLANS**

The Cairns Section covers an area of some 35 000 square kilometres and extends for more than 400 kilometres along the coast adjacent to the towns of Tully, Innisfail, Cairns, Mossman, Port Douglas and Cooktown (see Figure 1). The Cairns Section is one of four Sections making up the Great Barrier Reef Marine Park.

The Great Barrier Reef is the world's largest and most complex expanse of living coral reefs, encompassing many unique forms of marine life. Most of the Great Barrier Reef is in a relatively undisturbed condition.

In 1981 the Great Barrier Reef was inscribed on the World Heritage List in recognition of its universal value. Under the United Nations World Heritage Convention each country is required to do all it can to ensure the protection, conservation, preservation and transmission to future generations of these precious assets.

The development of the initial zoning plans for the Cairns Section and Cormorant Pass Section took place in 1982-83. The Cairns Section was the second major section of the Marine Park to be proclaimed when the rezoning took effect in November 1983.

The Great Barrier Reef Marine Park Authority (GBRMPA) has undertaken to revise zoning plans every 5-8 years. Since the first zoning plans for the Cairns Section came into effect many changes particularly in relation to tourism have occurred in this area.

The Cairns Marine Park was declared in 1989 and, beside including tidal waters around islands within the Cairns Section of the Great Barrier Reef Marine Park, also includes a number of major estuarine and inshore areas. This park is one of several State Marine Parks that have been declared along the coast of Queensland. The Cairns Marine Park includes much of the tidal lands and tidal waters between Mission Beach in the south and Murdoch Island in the north. State Marine Parks, including the Cairns Marine Park, are administered by the Department of Environment and Heritage (DEH).

To ensure the management of the Cairns Marine Park and the Cairns Section of the Great Barrier Reef Marine



Park are complementary, both zoning plans have been reviewed at the same time.

The revision of the Cairns Section Zoning Plan has involved a comprehensive program involving two formal public participation stages and much community consultation and discussion. As a result of the high profile of the issues in the media and meetings attended by staff of GBRMPA and the Queensland National Parks and Wildlife Service (Q.NPWS), a total of 1209 written representations including 208 form letters were received during the two periods of public participation.

Public comment was requested on the Cairns Marine Park during the second public participation phase on the proposed zoning plan for the Cairns Section of the Great Barrier Reef Marine Park. The existing Cairns Marine Park was shown on the proposed zoning plan map for the Cairns Section.

In addition to a request for comments on the existing Cairns Marine Park, the public was asked to comment on a number of proposed additions to the Marine Park and on Trinity Inlet as an area of interest for declaration as a Marine Park.

Of the submissions received in the second phase of public participation of the Cairns Section of the Great Barrier Reef Marine Park, 171 (14% of the total) referred to areas located only in the Cairns Marine Park.

# INITIATIVES

Major initiatives in the revised zoning plans are:

### **Zoning Names**

### No Structures Subzone

The introduction of the No Structures Subzone sets aside areas which must remain free from installations such as pontoons, except for approved navigation markers and vessel moorings. The introduction of this concept has wide support by reef users and conservation groups.

### **Fisheries Experimental Area**

Fisheries Experimental Areas have been introduced to help the conduct of a major research program to investigate the effects on the Reef of fishing. This research program has been widely supported despite some difficulty in finalising the locations of the Areas.

### **Conservation Park Zone**

The Marine National Park A Zone replaces the Conservation Park Zone. The right to "catch a feed" in this basically conservation zone has been extended to people spearfishing in some areas.

### Estuarine Conservation Zone

The new zone called the Estuarine Conservation Zone, replaces the old General Use B Zone where it applied to estuarine areas. This new zone provides for greater protection of estuarine habitat such as mangroves and underlying substrate.

### **New Additions**

A number of estuarine and coastal areas which were previously outside the Cairns Marine Park are now included. The estuaries of the Bloomfield and Johnstone Rivers, Dicksons Inlet and several other areas previously outside the Cairns Marine Park, are now included.

### **Aboriginal Management Area**

Aboriginal Management Areas provide for joint management of areas by DEH and by traditional Aboriginal owners. Mission Bay adjacent to the Yarrabah Aboriginal Community settlement has been declared an Aboriginal Management Area. Other similar areas may be declared during the life of the zoning plan.

# COMPLEMENTARY MANAGEMENT

All areas of the Great Barrier Reef Region, whether under the jurisdiction of the Commonwealth or Queensland, are managed in a similar way with regards to declaration, zoning and

day-to-day management. This inter agency relationship provides for more efficient and effective management of the Region.

# DAY-TO-DAY MANAGEMENT

DEH is the principal agency responsible for the day-to-day management of the Cairns Section of the Great Barrier Reef Marine Park and the Cairns Marine Park. Additional field management is undertaken by the Queensland Boating and Fisheries Patrol (QBFP) and aerial surveillance is carried out by Coastwatch.

Management of the Cairns Section of the Great Barrier Reef Marine Park and Cairns Marine Park commenced in 1983 and 1989 respectively and today encompasses a wide variety of tasks including education, permit assessment, surveillance and enforcement. DEH is also responsible for management of island National Parks.

## BOUNDARIES

Where possible boundaries have been drafted to use points that are readily recognised in the Marine Park, e.g. topographic features such as whole reefs or an entire bay. In some situations, such features do not occur and geographical co-ordinates have been used.

The inshore boundaries of the Marine Park are defined as extending to high water mark or highest astronomical tide along beaches and within estuaries. The Marine Park extends to high water mark around islands. Definitions of 'high water' and 'highest astronomical tide' are given in the zoning plans.

Other boundaries used to define the extent of Marine Parks are structures such as bridge crossings, freehold land and islands such as in the Annan River. Changes in vegetation types are often indicative of the boundary between the marine and terrestrial environments.

Boundaries of zones are also distinguished by physical features such as river bends, stable spits of land and river mouths.

In most cases, for zones such as Conservation Park, National Park, Buffer and Preservation, the boundary is *the 500 metre line* (i.e. the line every point of which is at a distance of 500 metres seaward from the nearest point of the *reef edge* of the *reef* to which it applies). Where the Habitat Protection Zone encircles these zones, the zone boundary is defined by coordinates to achieve large 'blocks' and *the one kilometre line* is generally used - to provide a 500 metre buffer beyond the more protected zone.

Some exceptions are:

- (a) a boundary 100 metres beyond LWM
   (low water mark) -- used to describe the outer boundary of the National Park Zone surrounding a number of small National Park islands located on incomplete reef platforms e.g. Rocky Islets, Three Islands, South Barnard Islands. These National Park Zones are then surrounded by a Buffer Zone out to the 500 metre line.
- (b) a boundary described by inset on a zoning map -- used where a readily discernible reef crest cannot be identified accurately to describe the boundary between the National Park Zone (or Preservation Zone) and the Buffer Zone. This is required when the National Park Zone or Preservation Zone is needed to protect the reef top (or reef crest) of a reef with important conservation values, but where trolling for pelagic fish is allowable over the reef slope (e.g. Euston Reef).
- c) a boundary described to the reef edge -used primarily on 'ribbon' and outer edge reefs which have steeply sloping edges, and thus the reef edge and reef crest are located very close to each other.

# NATURE CONSERVATION

### GENERAL

This section discusses each major issue addressed in preparation of the new zoning plans, and outlines the proposed action by GBRMPA and the DEH for each issue. For information on the background to declaration of the Cairns Marine Park refer to 'Background Report, Cairns Marine Park' published by the Department of Environment and Conservation 1989. Copies can be obtained from the DEH office, Cairns.

The two Marine Parks are multiple use parks which allow for all reasonable uses to be carried out provided they are consistent with the long-term conservation of the Great Barrier Reef Region. Activities which are prohibited throughout the Marine Park are littering, operations for recovery of oil and other minerals (except for approved research purposes), spearfishing with underwater breathing apparatus (except for the taking of spiny lobsters in the Far Northern Section), and the taking of large specimens of some fish species such as potato cod.

GBRMPA and DEH believe any use of the Reef or associated areas should not threaten its existing essential ecological characteristics and processes. This belief has led GBRMPA to adopt the following primary goal:

To provide for the protection, wise use, understanding and enjoyment of the Great Barrier Reef in perpetuity through the care and development of the Great Barrier Reef Marine Park.

Throughout the two periods of public input during the revision of the Cairns Section and Cairns Marine Park Zoning Plans, representations were received expressing concern that conservation of the Great Barrier Reef has taken a poor second place to tourism and, to a lesser extent, other special interest groups. Although not the true situation, this reaction is in response to the special emphasis placed on development of a strategy for the control of tourism in the Cairns Section and ultimately for the entire Marine Park.

At the other extreme, a number of representations commented that the draft zoning plan, developed for public comment during 1989, proposed protection for too large an area of the Marine Park, leaving insufficient areas for users to maintain current levels of operation. Emphasis on specific new strategies, such as the tourism strategy and the proposed effects of fishing experiment, may have led users to believe that large areas would no longer be available for use by the general public.

The Cairns Section is a relatively small and very intensively used part of the Marine Park. For that reason, the Cairns Section must be considered as part of an overall management strategy, encompassed by all zoning plans.

A well-planned and executed public awareness program will enable users to understand all elements of the new zoning plans, thus preventing dissatisfaction due to misunderstanding and lack of information.

The table overleaf summarises the area, in square kilometres, of the Cairns Section in each zone type for the revised zoning plan and provides a comparison with the previous zoning plan which has been in operation since 1983.

Public concern regarding loss of mangrove habitat and support for protection of estuarine habitats was expressed in submissions. The Cairns Marine Park was expanded to include the estuaries of the Annan, Bloomfield and Johnstone Rivers and Dicksons Inlet.

### SINK AND SOURCE REEFS

Scientific research has proved that most coral reef animals such as fish, corals and starfish produce offspring as pelagic (open water) larvae which spend the early days to weeks of their lives being carried by water currents. Many of these larvae will leave the reef where they were spawned (their source reef) and be carried towards other reefs. The reef on which larvae settle and grow into adults is referred to as the sink reef.

Research into water currents and the movement of larvae between reefs has led to the development of computer-based techniques to study the effectiveness of certain reefs or groups of reefs as 'sources' of larvae for the recruitment of organisms (corals and fish) to other reefs ('sinks'). A study into reef connectivity in the Cairns Section was commissioned by GBRMPA and undertaken by the Marine Modelling Unit of James Cook University .

Forty-six reefs presently within Marine National Park 'B', Scientific Research or Preservation Zones or proposed as Marine National Park Zones were studied using randomly selected current patterns. The reliability and effectiveness of the 46 reefs as 'sources' of larvae were analysed and the corresponding 'sink' reefs throughout the Cairns Section were identified. This information was used when the zoning for particular reefs was reviewed.

An effective 'source' reef is one that reliably supplies numerous larvae to two or more 'sink' reefs. Well-served 'sink' reefs are defined as being strongly replenished from two or more 'source' reefs.

### SEAGRASS

Seagrasses provide important habitat essential to the livelihood of dugong, turtles, commercial species such as prawns, and a variety of other marine fauna.

In the Marine Parks, the major threats to seagrass are through physical disturbance such as reclamation, dredging or indiscriminate trawling, or through degraded water quality changing the nutrient, turbidity or sediment levels. Protection of seagrass beds is an important and widely supported aim of the zoning plan.

All known areas of seagrass (surveyed by Queensland Department of Primary Industries) within the Marine Park have been zoned to afford protection from physical disturbance. Seagrass areas are described by the amount of surface area covered by foliage. Known areas in the Marine Park and their proposed zoning, are:

### DUGONG

The number of dugong in an area relates directly to the extent of seagrass in that area. The Starcke River area is prolific with about 20% of all known dugong in the Great Barrier Reef Region. South of Cape Bedford, the Cairns Section has little seagrass and no major dugong populations.

Within the Great Barrier Reef Region, permits are issued for dugong hunting by Aboriginals from several Trust areas. They are also killed accidentally in shark nets set for the protection of swimmers near major population centres and in commercial gill nets. The present level of dugong hunting in most areas by Aboriginals and Islanders is considered by researchers to be within the sustainable yield of the dugong population. The number of dugong killed in gill nets and shark nets is thought to be low. A comprehensive Great Barrier Reef wide Dugong Management Plan is proposed to be produced to address local and Reef-wide ecologically sustainable levels of harvesting and levels of unintentionally induced mortality.

Permits for traditional hunting may be issued to the Aboriginal or Islander community and include specific conditions. Conditions include a prohibition on the use of firearms or noxious substances, a prohibition on the sale or barter of any product caught, and a request for data on any dugong caught.

A report 'Biological Basis for Managing Dugong and other Vertebrates in the Great Barrier Reef Marine Park' (unpub) commissioned by the Authority from Dr Helene Marsh of the James Cook University of North Queensland provides excellent up-to-date information on the status of dugong with recommendations for future research, monitoring and management, including:

- 1. Protection of seagrass habitats, particularly those at Starcke River which support substantial numbers.
- 2. Inclusion of whole seagrass beds within zone boundaries.
- 3. Collection of dugong catch statistics from Aboriginal communities as a condition of hunting permits should continue.
- 4. Public education program about the dugong should target:
  - Aboriginal and Islander hunters living in Trust areas,
  - Aboriginals and Islanders living away from Trust areas, who resent not being able to hunt dugong legally, and
  - commercial gill netters operating in areas with high dugong densities.
- 5 Evaluation of the distribution and abundance of dugong using aerial surveys at five-yearly intervals.
- 6. Shark netters to be required through a permit to provide statistics on any dugong caught and make all dugong carcasses available for scientific research.

The following actions have been implemented to protect dugong in the Marine Parks:

- A five-yearly program to resurvey dugong populations has been instituted.
- Seagrasses are protected through their incorporation in the Habitat Protection, Estuarine Conservation, Conservation Park or National Park Zones.
- Where necessary, specific surveys of the extent of seagrass beds were carried out to identify the area to include in appropriate zones. Continuing survey work is required to verify available information and to take account of the seasonal variations in the extent of seagrass beds. Surveys of deepwater seagrass beds are required.
- Complementary zoning of intertidal areas has occurred. The extent to which dugong move into shallow (less than one metre) intertidal areas has been questioned, particularly in the Starcke River area where gill netters have operated over several years without apparent incidental capture of dugong.
- Public education programs are being developed and catch statistics will continue to be required as a condition of permits for traditional hunting of dugong.
- Under the revised zoning plan conditional permits will be required for shark netting programs.

### BIRDS

Important bird nesting sites have been identified throughout the Cairns Section. Seasonal Closure Areas have been proposed surrounding a number of these sites. Within a Seasonal Closure Area, most activities, except some research, are prohibited. The period of closure and the boundaries of the area are advertised.

### TURTLES

Turtle nesting occurs in small isolated areas in the marine parks, but these sites are not of significance on a regional (Great Barrier Reef) or world scale.

Turtles are seen regularly throughout the Marine Parks. Most sightings occur in the vicinity of known seagrass beds such as in Mission Bay near Cairns and around the Turtle Group and Nymph Island in the north of the Section.

Turtle hunting by Aboriginals and Islanders living in Trust areas takes place under permit in areas adjacent to communities.

### **REEF FISH SPAWNING LOCALITIES**

Of 29 localities identified by Queensland Department of Primary Industries staff as important spawning sites for coral trout, 13 are protectively zoned in the revised zoning plan. The remaining 16 localities are available for fishing. The locations of these important sites are being kept confidential to ensure some level of protection for the fish communities frequenting these areas.

# PARK MANAGEMENT

MOORINGS AND ANCHORAGES

In 1985-88 the number of registered private pleasure vessels in the Innisfail, Cairns and northern areas increased by 25% to more than 8000.

In recent years, many Marine Park users have become aware of the impact of boat anchors and mooring lines on the corals of the Great Barrier Reef. GBRMPA and DEH believe moorings are needed and should be installed at good or popular anchorages where corals are at risk. The mooring issue drew supportive comments in both phases of public participation. Moorings are preferable because they may be safer and less destructive than anchoring. With few exceptions, most respondents who were against structures on the reef were in favour of moorings, apparently appreciating the potential of moorings to reduce damage to coral caused by anchoring.

Several representations have been received commenting on the usefulness of the moorings installed at Cod Hole and Pixie Pinnacle and suggesting other sites in urgent need of moorings. These included Green Island, Beaver, Hastings and Pickersgill Reefs, and the Hope Islands.

Another major issue for anchorages is that many lie in the National Park zones. Many respondents felt that 'no fishing' at anchorages will be likely to cause people to break the rules. To date, in situations where a commercial tourist operator uses a site more than twice a week, GBRMPA and DEH have required the permit holder (in the case of a tourist operation) to install an environmentally acceptable mooring, approved by a marine architect, in an agreed location at the operator's cost. Sites visited regularly by a commercial operator are assessed by DEH for environmental impact, particularly with regards to potential coral damage. Under the new zoning plan, a permit is required for construction and conduct of a mooring. Installation of moorings for vessels is approved by DEH regional staff.

GBRMPA has approved the installation of public moorings in the Marine Park in locations where they will contribute to the conservation of the Great Barrier Reef. Contractors will be engaged to design, certify, install and maintain the public moorings.

The revised zoning plans retain access for small boats to important all-weather anchorages. Access to all zones is allowed in emergencies.

### FISHERIES EXPERIMENTAL AREAS

Research into the effects of recreational and professional fishing is a priority. Successful management of the Great Barrier Reef Marine Park relies on our understanding of the effects of our activities on the ecosystem and the informed regulation of such use. Scientific workshops in 1989 and 1990 discussed the best approach to research into the effects of trawling and line fishing on reefs in the Marine Park. Participants agreed that GBRMPA should foster a strategy of research involving the control and manipulation of fishing activities at a number of clusters or groups of reefs. The zoning provisions will be used to delineate reefs and areas selected for experimental treatments.

In the zoning plans, two clusters of 5-6 reefs will be zoned for effects of fishing research. The locations of the experimental areas and the reefs to be included in them were determined during the public participation program for the zoning plans review and in consultation with local and state interest groups. One cluster lies off Cape Tribulation and includes St. Crispin Reef, Undine Reef, Mackay Reef, Agincourt Reef No. 3, and Chinamans Reef. The second cluster is located adjacent to the southern boundary of the Cairns Section and includes Taylor Reef, Beaver Reef, Farguharson Reef, Potter Reef, Eddy Reef, and unnamed reef 17-060. The exact location of Fisheries Experimental Areas are given in the zoning plans.

With special permission from the Authority trawling may be allowed for the purposes of research in one of these clusters.

The research program on these reefs started in 1991 and the work is expected to involve researchers from the Queensland Department of Primary Industries, the Australian Institute of Marine Science, and James Cook University. The program is co-ordinated by GBRMPA and will rely on considerable support and involvement of recreational and professional fishermen. This research will provide a far greater understanding of the interactions between fishing activities and ecological processes in the Great Barrier Reef Region.

### **TROLLING AND BUFFER ZONES**

Trolling for pelagic species is carried out by commercial and recreational fishing groups and individuals. Due to the migratory nature of the species caught trolling, protective zoning of individual reefs is not effective. Also preliminary research has indicated that pelagic species generally do not prey on reef species. The Buffer Zone therefore allows trolling for pelagic species in areas where bottom fishing is not allowed, for example around the reef edge of selected reefs zoned National Park or Preservation.

GBRMPA has decided to retain the Marine National Park Buffer Zone but to rename it simply Buffer Zone. It will allow trolling for pelagic species between the reef edge and the reef crest on specific reefs only. Drift fishing for pelagic species will not be allowed in Buffer Zones.

The Buffer Zone is depicted clearly on the zoning map, but has not been reintroduced to all previous localities, for example the Lark Reef area or around all Preservation Zones. Where the boundary could not be defined by a written description in the zoning plan, it has been described by reference to a map.

### FISH FEEDING

Fish feeding and shark feeding are undertaken widely by recreational divers and as a component of tourist programs on the Great Barrier Reef.

Concern has been expressed that fish and shark feeding may:

- change the local fish population;
- increase localised nutrient input into the reef environment;
- be used as a pretext for garbage disposal;
- encourage aggressive behaviour in fish and attract sharks, increasing the risk of injury to reef users.

Fishing and fish feeding are conflicting activities. Advantage is often taken of tame fish as fish feeding makes the fish more vulnerable to being caught. At some popular tourist sites where fish feeding occurs, fishing is also allowed by the current zoning. Guidelines for fish feeding have been prepared which address the amounts and types of foods that should be used for fish feeding. Compliance with these guidelines will continue to be a condition of permit for those tourist programs that conduct fish and shark feeding.

GBRMPA has concluded that:

- 1. Regulation over and above that endorsed by the current policy is not justified on the basis of the representations.
- 2. Where appropriate, zoning will be applied to protect 'tame' fish and to enable viewing by divers and visitors such as the Cod Hole.
- 3. Special Management Areas may be designated around major tourist sites to control all types of fishing if they are not protected by National Park Zones.

### MARINE POLLUTION

### Sewage from vessels

Under the *Great Barrier Reef Marine Park Act* 1975, vessels fitted with holding tanks are not permitted to discharge sewage within 500 metres of the edge of a reef. They may discharge sewage anywhere else within the Great Barrier Reef Marine Park. No similar restrictions apply to vessels not fitted with holding tanks. At this time there is no legislative requirement to fit holding tanks to vessels. As commercial operators must obtain a Marine Parks Permit, GBRMPA can require them to fit holding tanks as a permit condition. This usually applies to operators who spend most of their time at one location.

### Sewage from land sources

Under a new GBRMPA policy, any new landbased facilities discharging sewage directly into the Marine Park must treat sewage to a tertiary level treatment (that is removal of nitrates and phosphates). Existing facilities are to treat sewage to a tertiary level by January 1996. Such facilities are mainly tourist resorts on Great Barrier Reef islands. No city or town located on the Queensland coast discharges sewage directly into the Marine Park. As the marine environment is a continuous medium, obviously sewage discharge from coastal centres can impact on the Marine Park. GBRMPA is exploring ways of working with local government authorities to ensure sewage treatment plants are upgraded to treat sewage to a tertiary level or dispose of effluent on land.

### Oil pollution

Annex I of the International Convention for the Prevention of Pollution from Ships,(MARPOL), deals with oil. Annex I came into force internationally in October 1983. The implementing Australian legislation came into effect later that year. This is the *Protection of the Sea (Prevention of Pollution from Ships) Act* 1983. Under this Act the Great Barrier Reef receives special protection. Vessels are prohibited from discharging any oil in most of the Great Barrier Reef Region. Fines of up to \$200 000 for an individual and \$1 000 000 for a body corporate apply for breaches.

### Garbage

Annex V of MARPOL deals with garbage. Annex V came into force internationally at the beginning of 1989. Implementing Australian legislation came into effect in November 1990. This is in the form of amendments to the *Protection of the Sea (Prevention of Pollution from Ships) Act.* The Great Barrier Reef receives special protection. Disposal of any form of garbage, including plastics, in most of the Great Barrier Reef Region (see map attached) is prohibited. The same fines as for oil apply for breaches.

### **Reception Facilities**

Under Annex V of the MARPOL Convention all ports are required to provide adequate facilities to receive garbage from vessels. Should a vessel not be able to find adequate facilities for its garbage in a port, that port should be reported to the address below. Legal action can be taken against any port failing to provide adequate facilities. ### **CROWN-OF-THORNS STARFISH**

Many reefs in the Cairns Section have been affected by the crown-of-thorns starfish (COTS). According to surveys undertaken by the Australian Institute of Marine Science, 37% of reefs surveyed in the Cooktown-Lizard Island sector, 34% of reefs surveyed in the Cairns-Port Douglas sector, and 66% of reefs surveyed in the Innisfail sector have been affected to varying degrees by the starfish in the most recent series of outbreaks, which started in 1979.

Few comments were received on the COTS issue during the two periods of public participation. The representations generally agree with the Authority strategy to conduct research rather than trying to control numbers of starfish or to eradicate them. Out of all reef users spearfishing enthusiasts have been identified as excellent reporters of starfish activity.

# **USE OF RESOURCES AND ACTIVITIES IN THE MARINE PARKS**

## TOURISM

Tourism in the Cairns Section, particularly out of Cairns and Port Douglas, has increased significantly over recent years. As tourist numbers grow there have been increases in:

- the number, size and speed of vessels, providing quicker access to a greater number of and more distant areas for larger numbers of people;
- the use of aircraft (seaplanes and helicopters) and hovercraft; and
- the number and size of tourist structures permanently located on the reef.

When the review for the zoning plans commenced GBRMPA believed that a strategy was needed to provide for the continued growth in tourism, to manage conflicts and to ensure that a range of tourism and recreational experiences continues to be available in the Marine Park:

There was widespread public support for the management of tourism in the Marine Park.

The No Structures Subzone has been introduced and management plans will be developed as required to specify in more detail how a specific site or a group of reefs will be managed and used in accordance with the relevant zoning provisions.

### **RECREATIONAL FISHING**

Fishing is one of the most popular recreational activities undertaken in the Cairns Section and Cairns Marine Park. Line fishing, spearfishing, bait netting, crabbing, light tackle and game fishing are all popular. Apart from shore-based bait netting and line fishing, access is generally by small, privately-owned boats or by larger charter boats which primarily conduct line fishing trips.

The number of people fishing recreationally has increased dramatically in the last 10 years and catches have fallen. The major concern of recreational fishing groups is that overfishing may be taking place at some popular sites. The second most mentioned concern is that favourite sites may be closed to fishing. Several management actions including seasonal or replenishment closures and bag limits were suggested.

Other issues raised in relation to recreational fishing were:

- the use of moorings at popular anchorages to prevent anchor damage to corals;
- bag limits on recreational fishing;

- seasonal closures to protect fish during spawning season;
- allowing fishing for meals/consumption in immediate area, e.g. at anchorages;
- allowing more than one line per person (in Conservation Park Zone); most would prefer one line for drift fishing and a floating bait;
- too many reefs closed in particular areas, e.g. within 20 miles of Innisfail;
- concern about exclusive use of reefs by tourist/mariculture operations; and
- impact of recreational fishing on commercial fishing

Specific actions proposed or being undertaken by the Authority are:

- 1. Further liaison with Queensland fisheries management agencies will occur to consider specific management of recreational fishing.
- 2. One objective of the Conservation Park Zone is to allow 'limited fishing', the philosophy being to allow users of the area to 'catch a feed'. The provisions have been changed to extend this privilege to recreational spearfishing at selected sites in this zone.
- 3. Evaluation of the closures within the Fisheries Experimental Areas is proposed through a co-ordinated program involving the Queensland Department of Primary Industries, Queensland Department of Environment and Heritage, Australian Institute of Marine Science, James Cook University, CSIRO and the Authority. The co-operation of the commercial and local recreational fishing communities in fishing open areas (when they are open) and avoiding closed areas (when they are closed) will be sought.
- 4. A research program to compare the impacts of spearfishing and line fishing will be conducted. Concerned organisations and clubs will be asked to participate in

developing and implementing this program.

### SPEARFISHING

In rezoning the Cairns Section of the Marine Park the relation between spearfishing and recreational fishing was a very contentious issue. Spearfishing in the Marine Park is restricted by the zoning plans and also by Queensland fisheries regulations. The restrictions ban spearfishing with underwater breathing apparatus other than a snorkel, ban spearfishing using a powerhead, ban the sale or trade of speared fish and prohibit spearfishing in certain zones or areas.

Whether spearfishing should be an allowable activity at all locations where line fishing is permitted has been debated by many user groups.

The pro-spearfishing lobby claims that spearfishing is less harmful than line fishing and therefore should be included where line fishing is allowed. Reasons given include:

- it has less impact on fish stocks because few people spearfish;
- very few people who spearfish are proficient;
- spearfishing is quite selective;
- people who spearfish only take what they need;
- spearfishing is restricted to certain areas of the reef by depth;
- spearfishing is difficult work; and
- fish have a more sporting chance.

Comments against spearfishing included the following:

- people who spearfish take any sized fish;
- people who spearfish wipe out fish populations;
- fish do not get a fair/sporting chance, especially tame fish; and
- spearfishing attracts undesirables such as sharks.

GBRMPA concluded that the public has popular misconceptions that spearfishing is dangerous and that users can catch whatever they like, whenever they like. Reports of speargun accidents are extremely rare. Due to the low numbers of participants in this activity, anglers have little to fear of speargun users depriving them of good fish. Unfortunately, a few spearfishing groups have given the sport a bad name by shooting tame fish and by occasionally making large catches during competitions. The Australian Coral Reef Society and a number of other groups have argued that because spearfishing can be more selective for particular types of fish it could have some significance at important scientific research and dive sites. This argument appears valid although it is significant only at a few sites, particularly around Lizard Island.

The zoning plan provides for spearfishing and line fishing generally to be treated identically, but spearfishing is further restricted at sites in the Conservation Park Zone.

### **COMMERCIAL FISHING**

Commercial fishing (including trawling, trolling, demersal line fishing, netting and crabbing) is widespread throughout the Cairns Section and Cairns Marine Park. Queensland Fish Management Authority (QFMA) records show the following commercial licences: Cairns 304, Innisfail 53, Port Douglas 41, Cooktown 8. The capital value of the local fleet (vessels and licences) is **estimated at \$94m**, with a further \$6m invested in associated equipment (QFMA records).

Virtually all those who hold commercial fishing licences are members of the Queensland Commercial Fishermen's Organisation (QCFO) with the activities of the industry being managed by the QFMA and the Queensland Department of Primary Industries (QDPI).

Several industry concerns were raised in representations and at meetings between GBRMPA/ DEH staff and a QCFO Liaison Committee:

• concerns about any further restrictions on

the areas available for fishing (the tourism strategy proposed initially was understood to impose major unacceptable restrictions);

- suggested amendments for gear stowage;
- allowing commercial bait netting for pelagic fish in Conservation Park Zones (like other zoning plans);
- using buffer zones to allow pelagic fishing; and
- providing adequate protection for important sea grass communities and other fish habitats.

Comments were received, particularly from recreational fishing groups, about the supposed adverse impacts of commercial fishing and the relative merits of restricting commercial or recreational fishing to the advantage of the other group. The policy of GBRMPA and of DEH is to focus on environment management issues, leaving the allocation of the available resource to practices under fisheries legislation.

The zoning plans have taken into account all available evidence to protect the resources of the Marine Parks while providing reasonable opportunity for fishing to continue. In particular, the use of sink/source data to assist in the identification of areas requiring high levels of protection and the application of broad-scale habitat protection measures have greatly strengthened the conservation basis for the zoning plans.

The Authority and fisheries management agencies are constantly reviewing the current fisheries management practices. Basic data on commercial fishing is constantly being updated and evaluated to determine if existing management practices require further refinement. Refinements can be implemented adequately through the GBRMP and fisheries regulations.

Further liaison between industry, the Authority and the relevant Queensland management agencies (QFMA, QDPI, QCFO and QBFP) is finalising amendments to gear stowage regulations for safer trawling operations.

Fishing around permanent tourist facilities may be controlled through the designation of Special Management Areas.

# COLLECTING (AQUARIUM FISH, CORAL, SHELL, TROCHUS, PEARL & CLAM)

Commercial and recreational collecting permits have been issued in the Cairns Section for a variety of products including aquarium fish, shells, coral and coral sand, trochus, beche-demer, seasnakes, and clams.

Collecting activities are controlled by QDPI permits (for commercial activities) as well as by Marine Parks permits.

Collecting activities are usually confined to a few sites because of the specific habitats of the sought-after species and, more often, the limited means collectors have for accessing sites.

Like all activities that exploit natural stocks, management must be aware of the potential for stock depletion by collectors, particularly at localised sites.

The zoning plan addresses collecting in the following manner:

- Amendments to the zoning plan allow, without a permit, crabbing, bait gathering, oyster gathering, and limited collecting in the General Use and Habitat Protection Zones. In addition, limited crabbing, bait gathering and limited oyster gathering are allowed in the Conservation Park Zone. Permits will continue to be required for commercial collecting and no collecting will be allowed in other zones (other than the collection of specimens for approved scientific research and by traditional inhabitants).
- 2. Although some sites will remain closed to fishing and collecting because priorities for conservation or tourism are higher, the zoning plan maintains reasonable opportunities for collecting. If conflict occurs, some further restrictions may be applied to fish collecting around permanent tourist

facilities through the designation of Special Management Areas.

# TRADITIONAL HUNTING AND FISHING

Aboriginal people live in several localities (Cairns, Kuranda, Gordonvale, Cooktown and Mossman) adjacent to the Marine Parks.

Three Aboriginal Trust areas (Hopevale, Wujal Wujal and Yarrabah) also lie adjacent to the Cairns Section. Traditional hunting and fishing by Aboriginals or Islanders from these communities are permitted in all zones except Preservation Zones.

Where appropriate, permits for traditional hunting or fishing are issued to the community with a number of specific permit conditions (e.g. a prohibition on the use of firearms or noxious substances, a prohibition on the sale or barter of any product caught, and a request for information on any dugong or turtle caught).

Representations indicate that Aboriginal communities have the following concerns:

- zoning plans are too complex for communities to understand;
- confusion is caused by too many pieces of State and Commonwealth legislation;
- conservation of dugong and turtles should be by joint management plans between the communities and management agencies;
- the communities should be involved in managing of adjacent Marine Park areas as rangers and as members of Management Committees; and
- lack of recognition of traditional hunting/ fishing areas in zoning plans; 'Aboriginal Cultural Management Zones' were suggested.

The Authority believes that the zoning plan has taken many steps to recognise the traditional rights of Aboriginal and Islander people. However, there can be no doubt that further ways to improve opportunities for traditional users of the Marine Parks must be investigated. Actions proposed by the Authority include:  It is a requirement of the zoning plan that management plans prepared for any areas of the Cairns Section address Aboriginal and Islander heritege.

1

- GBRMPA and DEH will implement man agement programs to involve Aboriginal and Islander communities in development of management plans for dugong and turtle.
- Traditional fishing is allowed 'as-of-right' in all zones where other fishing is allowed without a permit. However, until alterna tive management systems can be devel oped traditional hunting will still require a permit in all relevant zones.
- Mission Bay adjacent to Yarrabah Aboriginal Community has been designated as an 'Aboriginal Management Area' (AMA) in the Cairns Marine Park Zoning Plan. The provisions of an AMA provide for joint management of this area. Contract employment funds have been allocated to Yarrabah Aboriginal Community by the Australian National Parks and Wildlife Service for employment of Aborigines to help prepare a management plan for Mission Bay. They will be assisted by staff from DEH. Should this approach be successful and both the community and DEH feel that this is a useful way of managing areas adjacent to communities, the approach may be adopted elsewhere.

### MARICULTURE

Mariculture industries are developing and diversifying throughout the Great Barrier Reef. Some people believe the pearl nucleation industry could logically migrate to the Cairns area from Japan, with massive economic benefits to Australia. There is also the prospect of commercially viable markets for such species as giant clams and oysters. There is some possibility of cage culture of selected fish species proceeding. This industry is in very early development.

Mariculture operations have been included as a specific use requiring environmental impact assessment and management through the permit system. Some operations may have other requirements under the *Environment Protection (Impact of Proposals) Act* 1974.

The zoning plans address mariculture as follows:

- 1. Mariculture will not be allowed in Conservation Park, Buffer, National Park or Preservation Zones.
- 2. The identification of areas suitable for various types of mariculture will be investigated as part of the strategic planning exercise for these two Marine Parks.
- 3. Despite the drawbacks of exclusive use, potentially conflicting activities such as diving and fishing around established mariculture facilities can be controlled through the designation of Special Management Areas if necessary.

### DIVING

Diving is one of the most popular recreational activities undertaken in the Cairns Section of the Marine Park. Aside from private dive trips in small boats, estimates indicate that the divecharter industry has increased four-fold in the last eight years, with more than 30 charter vessels regularly engaged by the dive industry in the Section.

Over half the total 'diver-days' undertaken in Queensland occur in the Cairns region with the greatest proportion being overseas visitors. Trends indicate an increasing growth in demand for Great Barrier Reef diving, particularly from overseas visitors.

Diving is generally seen as a non-destructive, non-extractive activity and consequently few comments against it have been received. The major concerns were that careless dive groups may damage coral or interfere with mariculture sites.

Snorkellers tend to seek a quiet, relaxed, 'no fuss' experience at the reef and are in direct conflict (they feel) with spearfishing which is

carried out in the same shallow areas. They claim spearfishing destroys the 'wilderness' feel of a snorkel tour. The Authority does not believe it is appropriate for spearfishing to be banned in all shallow waters.

The zoning plans address diving as follows:

- 1. Under the zoning plans, diving may take place in all public-access zones without a permit.
- 2. Because of their size and specific site requirements of regular commercial operations, permits are required for conduct of tourist programs.
- 3. Requirements for spatial separation between diving and conflicting activities will be addressed in site-specific management plans.

### CAMPING

While all islands within the Great Barrier Reef Region are in the World Heritage Area, most islands in the Cairns Section and Cairns Marine Park are State lands managed by the Queensland National Parks and Wildlife Service as National Parks. A number of islands are Commonwealth owned and form part of the Great Barrier Reef Marine Park, including Rocky Island, Low Isles, Russell Island, Kent Island and part of Palfrey Island.

Camping on all islands within the Cairns Section and Cairns Marine Park whether they are owned by the Commonwealth or the State, requires the permission of the responsible agency. Where camping is appropriate, permits are issued by the DEH regional office.

### NAVIGATION AIDS AND SHIPPING

Marine navigation aids (navaids) in the Cairns Section include lighthouses, unmanned lights, buoys and unlit beacons. Offshore these are required primarily for commercial shipping in coastal waters, and the Australian Maritime Safety Authority (AMSA) is responsible for their establishment, operation and maintenance. AMSA also has responsibility for navaids in Queensland waters.

In 1990-91, more than 2000 vessel transits were recorded for the inner shipping route through the Great Barrier Reef (one-sixth of the total ship visits to Australia). Of these, some 300 transits were undertaken without a pilot. The International Maritime Organization (IMO) is concerned with the safety of shipping and the protection of the marine environment. In 1990, at the request of the Commonwealth Government, the 30th session of the Marine Environment Protection Committee of the IMO identified the Great Barrier Reef as a " Particularly Sensitive Area". The Commonwealth Government now requires ships 70 metres and over and all loaded oil tankers, chemical carriers or liquefied gas carriers to embark a pilot while navigating in the northern most section of the Great Barrier Reef and in Hydrographers Passage. This is considered the most practical means of reducing shipping accidents and the risk of serious pollution on the Great Barrier Reef.

Shipping in the Cairns Section is addressed as follows:

 International shipping is allowed in the General Use Zone, which covers all existing shipping channels. Shipping must conform with the IMO requirements, implemented through appropriate legislation administered by Department of Transport and Communications and the Australian Maritime Safety Authority.

- 2. The provision of new navaids should continue to be allowed in all public-access zones. All vessels, particularly commercial ships, rely on marine navaids for safe and economic navigation through the Great Barrier Reef.
- 3. Because many of the navaids are on islands which have high conservation values, the Authority may need to develop strategies to ensure AMSA's requirements for servicing of navaids is addressed, with minimal

ecological impact. Installation and servicing of navigation aids are designated notifiable activities in the zoning plan.

# ACTIVITIES OF THE DEPARTMENT OF DEFENCE

Four Defence Areas exist in the current zoning plans. These are declared under the *Defence Act* 1903 which overrides most other Acts. Defence Areas are set aside in the Great Barrier Reef in the interests of public safety to regulate public use and entry into these areas while they are being used for the conduct of defence operations.

Most of the Defence Areas are invoked only for short periods, e.g. the Defence Area over Flora, Coates, Gibson and part of Maori Reefs is invoked for weapons testing on an average of only one day a month, and rarely for more than about 3 hours on that day. Defence Areas are designated in the zoning plans and shown in zoning maps.

### EDUCATION PROGRAMS

All comments concerning 'education' addressed the need for increased and improved education of park users and specifically suggested that interpretive courses should be run by the Authority for tour operators.

Education in the Cairns Section is addressed as follows:

- GBRMPA/DEH interpretive programs for tourist operators will be continued and extended to other user groups including local boating or fishing clubs.
- 2. Limited educational programs conducted by schools or tertiary institutions, not involving taking of plants or animals, do not require a permit. Permits are required from GBRMPA for any other educational programs requiring removal of marine products.

### **RESEARCH ACTIVITIES**

The previous zoning plan allowed scientific research to be conducted throughout the Cairns Section. Permits were required for manipulative research, including collecting, in all zones and for non-manipulative research in all zones except General Use 'A' and General Use 'B' Zones. Under the new plan, limited research (defined as research that does not involve an activity that would otherwise require a permit in the zone) is allowed. Other research requires a permit in all zones.

In the previous zoning plan, a number of areas were set aside exclusively for research (Scientific Research Zones). The Authority considers that research needs can appropriately be addressed through the range of other zones. Therefore, the new plan has abolished the Scientific Research Zone, effectively amalgamating it with the Preservation Zone, except for the majority of the large Starcke River area which has been rezoned National Park Zone due to the frequent public use of the coastline adjacent to this zone.

### SAFETY IN MARINE PARKS

The fact that an activity is allowed by a zoning plan or under a permit granted by the Great Barrier Reef Marine Park Authority does not mean that it is necessarily safe. Certain hazards exist, unexploded ordnance for example, which may curtail or otherwise affect certain activities, in particular seabed activities. Further information should be obtained from navigation charts, Notices to Mariners and the Great Barrier Reef Marine Park Authority prior to entry into the Marine Park.

AUTHORITY COMMENTS - This area has very high values for conservation and there is concern that the existing level and type of use is inappropriate. Effective and reliable source reef. A significant sea bird nesting site. A vegetated cay and representative reef habitat type. Existing NPZ maintained as it provides adequate protection for the seabird colony and NSZ will prevent undue disturbance in time. Existing operators may be issued permits to remain as non-conforming uses but the long term aim will be to ensure that the number of visitors is in accord with existing numbers in the Management Plan.

AUTHORITY COMMENTS - This effective and reliable source reef previously had limited access as a SRZ; the PZ will maintain this situation. The Draft Zoning Plan proposed PZ to the 500m line but this area is very important for game fishing and evidence available suggests that trolling for pelagic species over the reef slope will not have have significant impact on the reef communities. This use has therefore been allowed through Buffer Zoning. The Buffer Zone should satisfy troll fishermen but must be clearly defined and publicised.
