Representative Areas Update

The new Zoning Plan and associated regulations will become law on Thursday, **1 July 2004**. Until then, all existing Zoning Plans for the Great Barrier Reef Marine Park remain in effect.

In the weeks leading up to 1 July 2004, information on the new Zoning Plan will be forwarded to all operators and be available generally in local communities. In addition, the GBRMPA staff will be available for meetings and information sessions.

Reminder to Make Use of Your Permit

Do you have a special tourism permission? Special tourism permissions allow you to conduct a particular tourism activity that has been capped or limited.

Your tourism program permit is likely to be a special tourism permission if it allows one or more of the following in the Cairns or Whitsundays Planning Areas:

- more than 50 days access per year without a booking (Whitsundays)
- more than 50 days anchoring access per year without a booking (Cairns)
- more than 50 days access per year to a Sensitive Location without a booking (Cairns) or access to a setting 5 area (Whitsundays)
- more than 50 days anchoring access per year to a Location (Cairns)
- a larger group size than that provided for in the setting (both areas)
- long range roving operations (both areas) or bareboat operations (Whitsundays)
- the activities of whale watching (both areas) and swimming-with-whales (Cairns)

let's keep it great

 the activities of reef walking other than at Hardy Reef or Black Island Reef and fishing in the Marine National Park 'A' zones (Whitsundays).

If your special tourism permission is due to expire after 13 August 2004 and you apply for a new permit to replace it, the GBRMPA will review whether you have made reasonable use of your permit. For most special tourism permissions this is an average of 91 days per year for every primary vessel or aircraft.

Tourism and Recreation Reef Advisory Committee (TRRAC)

GST and the EMC

In response to concerns by the industry about GST on the Environmental Management Charge (EMC), changes have been introduced so that, from 20 April 2004, operators will not be required to pay GST on the EMC. The liability to pay the standard tourism program charge has been shifted to the visitor. The operator is required to collect that amount from the visitor and pay it to the GBRMPA.

Whale Season Is Almost Upon Us

Every year the number of whales visiting the Great Barrier Reef is increasing. Whales are social animals and may approach boats or people in the water so if you are operating a vessel or aircraft, be alert and watch for whales at all times (especially from May to September). If there is a sudden change in whale behaviour, move away immediately. Report sick, injured, stranded or dead whales to the Marine Animal Hotline on 1300 360 898. Approach restrictions and best practices you should follow during the whale season can be found at the GBRMPA web site: www.gbrmpa.gov.au

Commercial operators require a specific Marine Parks permit before offering whale watching or swimming-with-whales activities.
