CONDITIONS FOR ALL PERMISSIONS

- G1 Unless otherwise indicated in this permit, the Permit Holder must:
 - (i) not use or enter the Marine Parks in a manner that is inconsistent with the provisions contained in Part 1 of a Plan of Management;
 - (ii) not contravene a provision contained in Part 2 of a Plan of Management; and
 - (iii) only access an intertidal area adjacent to a Planning Area location in a manner consistent with that provided in a Plan of Management for the Planning Area location itself.
- G2 The Permit Holder must:
 - (i) not use or enter the Restricted Access Special Management Areas at any time, other than in accordance with condition C6;
 - (ii) not use or enter the Maritime Cultural Heritage Special Management Areas except for the purpose of transiting, other than in accordance with condition C6; and
 - (iii) only use or enter Special Management Areas in accordance with the restrictions specified in the Great Barrier Reef Marine Park Regulations 2019 (Cth) and the Great Barrier Reef Marine Park Zoning Plan 2003 (Cth).
- G3 Upon request by the Managing Agency, the Permit Holder must produce, within the time specified in the request, any document or information:
 - (i) in relation to the activities covered by this permit; or
 - (ii) otherwise required by a law or by some other enforceable obligation.

For the purposes of this condition, any document or information includes, but is not limited to, reports, certificates, approvals, data and copies of documents.

AUTHORITY CONDITIONS

- G4 The Permit Holder may authorise other persons to conduct the activities covered by this permit, by giving to those persons an Authority in the form attached to this permit (Attachment A) or in some other form approved by the Managing Agency.
- G5 An Authority remains valid for the period of time shown on it, unless the Authority is sooner revoked in writing by the Permit Holder or unless the permission(s) to which the Authority applies is sooner suspended, revoked or expires.
- G6 The Permit Holder must provide a copy of this permit to any person given an Authority under condition G4.

INDEMNITY, WARRANTY, RISK AND INSURANCE REQUIREMENTS

- G7 The Permit Holder releases the Managing Agency, to the full extent permitted by law, from and Indemnifies the Managing Agency against all Claims arising from the Managing Agency's issue and supervision of this permit and the Managing Agency's management of the Marine Parks except to the extent that a Claim is caused or contributed to by the negligence of the Managing Agency, its servants or agents.
- G8 To avoid doubt, the release referred to in condition G7 extends to Claims arising from the Managing Agency's exercise of its rights under this permit and under all applicable legislation and related documents.
- G9 In addition to the indemnity in condition G7, the Permit Holder Indemnifies the Managing Agency against all Claims arising from or related to:
 - (i) the occupation and use of the Marine Parks by Affected Persons;
 - (ii) the conduct of, or participation, in the permitted use by Affected Persons;
 - (iii) the presence of an Affected Person in the Marine Parks in connection with this permit; and
 - (iv) a breach, by an Affected Person, of this permit,

except to the extent that a Claim is caused or contributed to by the negligence of the Managing Agency, its servants or agents.

G10 The Permit Holder must notify the Managing Agency in writing of any Claim Event immediately upon the Permit Holder becoming aware of the Claim Event.

- G11 The Managing Agency does not warrant that the Marine Parks are free from defect or that they are safe, fit, suitable or adequate for the permitted use. To the full extent permitted by law, all warranties as to safety, fitness, suitability and adequacy implied by law are expressly excluded.
- G12 The Permit Holder uses the Marine Parks entirely at its own risk and is responsible for ensuring the area is suitable for the permitted use prior to commencing any permitted use.
- G13 For the term of this permit, the Permit Holder must take out and maintain Appropriate Insurance.
- G14 From time to time the Managing Agency may, by notice to the Permit Holder, increase the minimum level of Appropriate Insurance cover if the Managing Agency reasonably believes such an increase is required.
- G15 The Permit Holder must ensure that the Appropriate Insurance policies are effected with an Appropriate Insurer.
- G16 The Permit Holder must ensure that the Appropriate Insurance policies cover all invitees, employees, contractors, agents, members or clients of the Permit Holder and names the Managing Agency as an interested party.
- G17 In any circumstance where a policy for an Appropriate Insurance is cancelled, altered or expires before the expiry date of this permit, the Permit Holder must cease all activities in the Marine Parks until such time as an alternative Appropriate Insurance policy has been obtained.
- G18 The Permit Holder is deemed to have complied with condition G13, where the Permit Holder:
 - (i) is a Commonwealth, State or Territory government department, agency or statutory body; and
 (ii) is a self-insurer; and
 - (iii) has provided the Managing Agency with a certificate from an authorised officer of that department, agency or statutory body, to that effect.

INCIDENT REPORTING REQUIREMENTS

- G19 On becoming aware of an incident the Permit Holder must notify the Managing Agency without delay. The notification must include:
 - (i) details of the incident including date, time, place, cause and nature of the incident;
 - (ii) the name and contact details of the person(s) witnessing, reporting and/or responsible for the incident;
 - (iii) the type, estimated volume and concentration of any pollutants involved;
 - (iv) the type and number of any pests involved;
 - (v) the type and estimated scale of any physical damage to the environment that has occurred and/or may occur; and
 - (vi) measures taken or proposed to be taken to mitigate physical damage to the environment and the success and/or likelihood of success of those measures.
- G20 If requested by the Managing Agency, a written incident report must be provided to the Managing Agency within 24 hours of the request. This written incident report must include the details specified in condition G19 as well as the following additional details:
 - (i) measures taken or proposed to prevent or mitigate against the recurrence of such an incident; and
 (ii) any other relevant matters determined by the Permit Holder or as directed by the Managing Agency.

VESSELS, AIRCRAFT AND EQUIPMENT

PERMITTED VESSEL(S) OR AIRCRAFT

G21 The Permit Holder must only use the following types of vessels or aircraft under this permit:

- G22 Prior to operating any vessel or aircraft under this permit, the Permit Holder must:
 - (i) give written notification to the Great Barrier Reef Marine Park Authority of the vessel name or aircraft type and registration number of the specific vessel or aircraft to be operated under this permit; and
 - (ii) obtain written approval for use of that vessel or aircraft from the Managing Agency.
- G23 A copy of the written approval given by the Managing Agency under condition G22(ii) must be held onboard the vessel or aircraft at all times.
- G24 An approval under condition G22(ii) above ceases to have effect for a specific vessel or aircraft when a subsequent approval for the same or any other vessel or aircraft is given under that condition.

PERMITTED EQUIPMENT

G25 The following types of equipment may be used under this permit:

PERMITTED ACTIVITIES

G26 In addition to provision of general services to tourists, the Permit Holder may only conduct the following tourist activities, for the purposes for which permission(s) has been granted under this permit, provided they are conducted no more than three (3) nautical miles from the primary vessel or aircraft and in accordance with the conditions of this permit:

BEACH LANDINGS

- G27 When accessing locations outside a Planning Area, the Fitzroy Marine Management Area and the Far Northern Management Areas, the Permit Holder must not access intertidal areas adjacent to a national park with a group size of more than 24 passengers (excluding crew) at any one time unless otherwise specified at condition G288 or approved in writing by the Managing Agency.
- G28 The Permit Holder may access the following intertidal areas, with the group size specified, subject to a prior booking with the Department of Environment and Science to access the national park in accordance with a valid authority under the *Nature Conservation Act 1992* (Qld):

- G29 When undertaking beach landings without an Intertidal Areas Notification Approval, the Permit Holder must only:
 - (i) remain in the intertidal areas while loading or unloading passengers; and
 - (ii) access intertidal areas using a vessel no greater than 12 metres in overall length unless the Permit Holder is using a vessel access facility that is of a type and design suitable for the vessel.
- G30 If access to other intertidal areas is required when undertaking beach landings using a vessel greater than 12 metres in overall length, the Permit Holder must:
 - (i) only access the intertidal areas listed in an Intertidal Areas Notification Approval provided by the Managing Agency to the Permit Holder with this permit, or provided by the Managing Agency to the Permit Holder in response to a written notice given in accordance with condition G30(ii);
 - (ii) provide the Managing Agency with at least 14 days written notice if the Permit Holder requests access to any intertidal areas not already listed in an Intertidal Areas Notification Approval provided to the Permit Holder under condition G30(i);
 - (iii) comply with any direction provided by the Managing Agency to the Permit Holder relating to access to intertidal areas; and
 - (iv) keep a copy of all Intertidal Areas Notification Approvals provided to the Permit Holder under condition G30(i) with this permit.

CORAL VIEWING

- G31 Any mini-submarine used under this permit must:
 - (i) not exceed an overall length of six (6) metres; and
 - stow or secure robotic manipulator arms when the vessel is in operation, unless the vessel is chartered for other permitted conduct which specifically permits taking an animal, plant or marine product.

FISHING

G32 The Permit Holder must only offer fishing activities in accordance with the Zoning Plans.

GUIDED TOURS (VESSEL-BASED AND AIRCRAFT-BASED)

- G33 When conducting guided tours using motorised or non-motorised equipment, the Permit Holder must ensure that all equipment is operated under the active supervision of crew where:
 - (i) a minimum of one (1) crew member is present with every 10 participants; and
 - (ii) the supervising crew member(s) remains in the water for the duration of the activity.

Advisory note: This is not intended to override any Workplace Health and Safety Queensland requirements or other safety regulations. If such legislation requires a smaller ratio then the permit holder must comply with that requirement.

- G34 When conducting guided tours using jet skis, the Permit Holder must:
 - (i) not operate more than four (4) jet skis in the water at any one time;
 - (ii) comply with the vessel operation conditions of this permit; and
 - (iii) not operate a jet ski in the Guided Jet Ski Tour Exclusion Areas listed in Attachment D.
- G35 The Permit Holder must ensure that aquatic devices are not operated:
 - (i) within two (2) metres of coral;
 - (ii) at a speed greater than five (5) knots;
 - (iii) at a depth greater than five (5) metres; and
 - (iv) in a manner similar to a motorised water sports.
- G36 The Permit Holder must ensure that helmet divers:
 - (i) do not operate within two (2) metres of coral, or other sessile marine fauna and flora;
 - (ii) do not chase or threaten mobile marine fauna; and
 - (iii) only walk on bare sand and do not walk on coral, seagrass or other marine organisms.

MOTORISED WATER SPORTS

G37 The Permit Holder must not conduct motorised water sports in the Motorised Water Sports Exclusion Areas listed in Attachment D.

ECO-ACCREDITATION -(IF APPLICABLE)

- G38 Throughout the term of the permit, certifiable activities conducted under this permit must remain duly certified by or under an approved Certification Scheme, unless otherwise advised in writing by the Managing Agency.
- G39 The Permit Holder must allow the Managing Agency and/or the person operating the approved Certification Scheme, and their respective officers, employees, agents and contractors, to assess, inspect, monitor and/or audit the conduct of the certified activities and/or facilities which relate to this permit.

VESSEL OPERATION CONDITIONS

PERMITTED ACCESS OUTSIDE A PLANNING AREA

- V1 The Permit Holder must not visit a permitted location outside a Planning Area and the Fitzroy Marine Management Area on more than two (2) visits in any seven (7) consecutive day period with each vessel except when operating:
 - (i) to a permitted mooring or pontoon not located at Fitzroy Reef (23-077) and Lady Musgrave Island Reef (23-082); or
 - (ii) as specified in condition V2.

Advisory Note: For the purposes of this condition the Marine National Park Zone in Five Beach Bay (Magnetic Island) is considered as one (1) location and Lady Musgrave Island Reef is considered as one (1) location.

- V2 If visiting primarily for the purposes of gamefishing, the Permit Holder may visit a permitted location in the Cairns/Cooktown Seasonal Gamefishing Area for up to 30 days in any 60-day period with each vessel during the period 1 September to 31 December each year.
- V3 The Permit Holder must not operate a vessel in the Vessel Exclusion Areas listed in Attachment D, during the periods specified in Attachment D, unless otherwise approved in writing by the Managing Agency.

STATE FITZROY MARINE MANAGEMENT AREA

- V4 When conducting a tourist program, the Permit Holder must not access the Fitzroy Marine Management Area on more than 50 days in a year with each vessel and without a prior booking with the Department of Environment and Science via the Great Barrier Reef Marine Park Authority's Bookings Online Portal, unless sourcing clients only from within the Fitzroy Marine Management Area.
- V5 The Permit Holder must not access the following locations within the Fitzroy Marine Management Area:
 - (i) Locality 1 and Locality 2 with a group size of more than 60 people;
 - (ii) Locality 3 with a group size of more than 15 people, unless operating to a permitted mooring where a maximum group size of 60 people is permitted; and
 - (iii) Locality 4 with a group size of more than 15 people.

Advisory Note: For the purpose of this condition, a calculation of the number of people that a vessel is carrying must include each person on board the vessel who is aged 4 years or older (including the officers and members of the vessel's crew).

- V6 The Permit Holder must not access the intertidal area of the Fitzroy Marine Management Area Locality 4 (Nudey Beach) between 9:30am and 3:30pm.
- V7 The Permit Holder must not store any equipment or vessels associated with the permitted activities within the Fitzroy Marine Management Area, unless moored on a permitted mooring.

STATE INTERTIDAL AREAS ADJACENT TO CEDAR BAY NATIONAL PARK

- V8 The Permit Holder may access the intertidal area adjacent to Cedar Bay National Park only for the purpose of dropping off and/or picking up persons who are either:
 - (i) the holders of a national parks camping permit valid for camping in the Cedar Bay National Park on the given dates; or
 - (ii) intending to hike out of the Cedar Bay National Park on that day.

The Permit Holder must only stay in the vicinity as long as required to effect the transfer.

MAGNETIC ISLAND, GREAT PALM ISLAND AND ORPHEUS ISLAND

- V9 The Permit Holder must not access Balding Bay (Magnetic Island) or Florence Bay (Magnetic Island) (including the intertidal areas) on a Saturday or a Sunday.
- V10 When accessing the Great Palm Island Group, the Permit Holder is exempt from condition G27 when conducting activities on behalf of residents of Great Palm Island.

- V11 The Permit Holder may access intertidal areas adjacent to:
 - (i) Hazard Bay and Yanks Jetty (Orpheus Island); and
 - (ii) Horseshoe Bay, Geoffrey Bay, Nelly Bay and Picnic Bay (Magnetic Island);
 - with a maximum of 50 passengers (excluding crew).

STATE INTERNAL WATERS ADJACENT TO HINCHINBROOK PLANNING AREA

- V12 The Permit Holder must not visit a Hinchinbrook Channel Location on more than 50 days a year with each vessel and without a prior booking with the Department of Environment and Science via the Great Barrier Reef Marine Park Authority's Bookings Online Portal, except when conducting:
 - (i) a guided interpretive tour using a vessel less than six (6) metres in overall length; or
 - (ii) a passenger transport operation (Hinchinbrook) provided the Permit Holder does not access the Eastern Hinchinbrook Channel Location, Western Hinchinbrook Channel Location or Hecate Point Location.
- V13 When permitted activities are conducted in a Hinchinbrook Channel Location, the Permit Holder is required to keep data records of these activities as follows:
 - (i) the number of trips per day to each location; and
 - (ii) the number of persons per vessel per day (excluding crew) utilising the Permit Holder's tourist program.

The Permit Holder must forward these records on the form supplied every three (3) months or upon request by an officer of the Managing Agency to the Department of Environment and Science by email to permitsGBR@des.qld.gov.au. The return must be submitted no later than 30 days after the last day of the three (3) month period. If no permitted activities have been undertaken under this condition then a return is not required to be submitted.

- V14 When conducting a passenger transport operation (Hinchinbrook) the Permit Holder must not transfer passengers for the Thorsborne Trail into the intertidal area of George Point.
- V15 When conducting a tourist program in the Haven/Scraggy Point Location, Hecate Point Location, Eastern Hinchinbrook Channel Location and Western Hinchinbrook Channel Location, the Permit Holder must not operate a vessel carrying more than:
 - (i) 100 people (including crew), into a high use setting Location except when transiting through the Haven/Scraggy Point Location;
 - (ii) 30 people (including crew), into a moderate use setting Location; and
 - (iii) 15 people (including crew), into a low use setting Location.
- V16 The Permit Holder must not conduct non-motorised water sports within a Hinchinbrook Channel Location or the Missionary Bay Location.

STATE INTERTIDAL AREAS ADJACENT TO WHITSUNDAY PLANNING AREA

- V17 The Permit Holder may only access the intertidal area abutting Tongue Point on Whitsunday Island in accordance with the following:
 - (i) the Permit Holder must hold a relevant authority issued under the *Nature Conservation Act* 1992 (Qld) allowing access to the Tongue Point walking tracks; and
 - (ii) the Permit Holder may only access the intertidal area of Lookout Beach and Betty's Beach via foot.

Advisory Note: The Permit Holder is advised that the commercial use of intertidal areas adjacent to the Whitsunday Planning Area will be subject to review. The Permit Holder is further advised that should that review determine commercial use is unsuitable at some sites, those sites may be removed from this permit until further notice.

STATE INTERTIDAL AREAS OF MACKAY/CAPRICORN MANAGEMENT AREA

- V18 Unless otherwise approved in writing by the Managing Agency, the Permit Holder must not enter the following intertidal areas for any purpose except for the pick up and drop off of passengers as specified:
 - (i) the two (2) beaches adjacent to the Environmental Centre at North Keppel Island passengers for the Konomie Island Environmental Education Centre; and
 - (ii) Considine Beach (North Keppel Island), Humpy Island, Miall Island, Middle Island, Pleasant (Conical) Island, Lady Musgrave Island, Masthead Island and within 1km of North West Island – passengers who hold a camping permit or are clients of the holder of a valid authority under the Nature Conservation Act 1992 (Qld) for the adjacent national park.
- V19 The Permit Holder may access the intertidal area of Lady Musgrave Island:
 - (i) with a maximum group size of 10 people; and
 - subject to a prior booking with the Department of Environment and Science by emailing permitsGBR@des.qld.gov.au to access the national park in accordance with a valid authority under the Nature Conservation Act 1992 (Qld).

PERMITTED ACCESS IN A PLANNING AREA

V20 The following tourism operations are permitted with all vessels in accordance with condition G1:

GREAT BARRIER REEF COAST MARINE PARK RIVERS AND STREAMS PROGRAM CONDITIONS

- Q1 The Permit Holder must not exceed a passenger capacity of 12 passengers excluding crew.
- Q2 The Permit Holder must conduct any spotlighting activities in accordance with the Department of Environment and Science Best Practice Code for Conducting Spotlighting.
- Q3 The Permit Holder must take all reasonable steps to minimise disturbance to river banks and river beds and damage to shoreline vegetation.
- Q4 When permitted activities are conducted in the Great Barrier Reef Coast Marine Park rivers, streams and inlets, the Permit Holder is required to keep data records of these activities as follows:
 - (i) a list of permitted locations (rivers/streams/inlets) visited each day;
 - (ii) the number of trips per day to each location; and
 - (iii) the number of persons per vessel per day (excluding crew) utilising the Permit Holder's tourist program.

The Permit Holder must forward these records on the form supplied every three (3) months or upon request by an officer of the Managing Agency to the Department of Environment and Science by email to permitsGBR@des.qld.gov.au. The return must be submitted no later than 30 days after the last day of the three (3) month period. If no permitted activities have been undertaken under this condition then a return is not required to be submitted.

PERMITTED ACCESS

- Q5 The Permit Holder must not visit a permitted location on more than two (2) visits in any seven (7) consecutive day period when using each vessel.
- Q6 The Permit Holder must only conduct activities between 0600 and 2100.
- Q7 The Permit Holder may only access the following rivers, streams and inlets:

PERMITTED ACCESS OUTSIDE A PLANNING AREA

- A1 The Permit Holder must not visit a permitted location, other than an intertidal area, outside a Planning Area on more than two (2) visits in any seven (7) consecutive day period with each aircraft. This condition does not apply if the Permit Holder is operating to a permitted mooring or pontoon not located at Fitzroy Reef (23-077) and Lady Musgrave Island Reef (23-082).
- A2 The Permit Holder must not land or operate aircraft at a height less than 1500 feet in the intertidal area at a permitted location outside a Planning Area on more than two (2) visits in any seven (7) consecutive day period in total with all aircraft.
- A3 The Permit Holder must not operate an aircraft at a height less than 1500 feet in the intertidal area adjacent to a national park or residential areas unless otherwise endorsed on the permit or when in transit for landing/take-off from a location outside the Marine Parks.
- A4 Unless otherwise approved in writing by the Managing Agency, the Permit Holder may only land in an intertidal area adjacent to a national park if the intertidal area is adjacent to a regular aircraft landing area as specified in the Whitsundays Plan of Management.
- A5 Unless otherwise approved in writing by the Managing Agency or when in transit for landing/take off from a location outside the Marine Parks, the Permit Holder must not operate an aircraft in the Aircraft Exclusion Areas listed in Attachment D, during the periods specified in Attachment D, when:
 - (i) operating an aircraft at a height less than 1500 feet; or
 - (ii) landing or taking-off by aircraft; or
 - (iii) taxiing the aircraft.

STATE INTERTIDAL AREAS ADJACENT TO CAIRNS PLANNING AREA

- A6 Unless otherwise endorsed on this permit, the Permit Holder must only conduct helicopter landings on:
 - (i) Vlasoff Cay (all year) and Undine Cay (from 1 April to 31 August); or
 - (ii) pontoons, helipads, vessels and the water.
- A7 The Permit Holder must only conduct helicopter landings at the permitted cays when:
 - (i) there are no other aircraft present at or adjacent to the cay; and
 - (ii) there are no people on the cay or in waters adjacent to the cay; or
 - (iii) the prior consent of other aircraft operators and/or people present on the cay or in the waters adjacent to the cay has been obtained.

STATE INTERNAL WATERS ADJACENT TO HINCHINBROOK PLANNING AREA

- A8 When conducting a tourist program, the Permit Holder must not operate aircraft at a height less than 1500 feet in a Hinchinbrook Channel Location:
 - (i) on more than 50 days per year (in total with all aircraft); and
 - (ii) without a prior booking with the Department of Environment and Science via the Great Barrier Reef Marine Park Authority's Bookings Online Portal.
- A9 The Permit Holder may only access a Hinchinbrook Channel Location to conduct one (1) return trip per day in total with all aircraft.
- A10 The Permit Holder must not operate below a height of 1500 feet (above ground or water) when:
 - (i) over a Hinchinbrook Channel Location, except when landing at or taking off from the Dunk Island airport or any other designated aircraft landing area adjacent to the Hinchinbrook Planning Area; or
 - (ii) within 1000 metres seaward from the Ramsay Bay Location, East Coast Hinchinbrook Island Location, Zoe Bay Location, Mulligan Bay Location and Picnic Beach Location.

MAGNETIC ISLAND

A11 When conducting a tourist program, the Permit Holder must not operate an aircraft at a vertical height less than 1500 feet in the vicinity of Magnetic Island (the prescribed area) except in the course of landing, taking off or taxiing an aircraft seaward of the intertidal area at Horseshoe Bay, Nelly Bay or Picnic Bay.

Advisory Note: Despite condition A11, for emergency or other extraordinary reasons, Air Traffic Control requires the aircraft to fly within the prescribed area. The Permit Holder shall ensure that any airways clearance requested from Air Traffic Control shall be for outside the prescribed area except in the course of landing, take-off or taxiing at Horseshoe Bay, Nelly Bay and Picnic Bay.

- A12 When conducting a tourist program in the prescribed area, the Permit Holder must not operate before 0900 hours or after 1700 hours on any day.
- A13 Notwithstanding conditions A1 and A2, when conducting a tourist program anywhere within the prescribed area, the Permit Holder must not operate on more than six (6) days in any seven (7) consecutive day period, with each aircraft.
- A14 When conducting a tourist program anywhere in the prescribed area and subject to conditions A1 and A2, the Permit Holder must not operate more than eight (8) flights total on any day.

MACKAY/CAPRICORN MANAGEMENT AREAS

- A15 When operating an aircraft in the Mackay/Capricorn Management Areas, the Permit Holder must ensure that:
 - (i) the aircraft does not taxi onto or stand upon beaches except when transferring passengers; and
 - (ii) the aircraft's landing and take-off approaches below 500 feet do not traverse Marine National Park Zones except when weather conditions make alternate routes unsafe.

PERMITTED ACCESS IN A PLANNING AREA

A16 The following tourism operations are permitted with all aircraft in accordance with condition G1:

CRAFTLESS OPERATION CONDITIONS

- F1 The Permit Holder must ensure that the use of, or entry to, the Marine Parks when using a vessel or aircraft for transport:
 - (i) takes place using a vessel or aircraft permitted under a valid Marine Parks permission;
 - (ii) occurs in the zones and locations as specified in the permission for that vessel or aircraft; and
 - (iii) operates under the same access and activity conditions as the permitted vessel or aircraft that is being used.

Advisory Note: The permission does not allow the independent operation of a vessel or aircraft. Use of the Marine Park is restricted to use without a vessel or aircraft (shore-based) or as a 'piggyback' operation on a vessel or aircraft already permitted under another Marine Parks permission.

- F2 When operating from the shore, the Permit Holder must:
 - (i) only access the intertidal areas listed in an Intertidal Areas Notification Approval provided by the Managing Agency to the Permit Holder with this permit, or provided by the Managing Agency to the Permit Holder in response to a written notice given in accordance with condition F2(ii);
 - (ii) provide the Managing Agency with at least 14 days written notice if the Permit Holder requests access to any intertidal areas not already listed in an Intertidal Areas Notification Approval provided to the Permit Holder under condition F2(i);
 - (iii) comply with any direction provided by the Managing Agency to the Permit Holder relating to access to intertidal areas; and
 - (iv) keep a copy of all Intertidal Areas Notification Approvals provided to the Permit Holder under condition F2(i) with this permit.

CHARTER OPERATION CONDITIONS

WITHOUT NOTIFICATION

- C1 When conducting charter operations, the Permit Holder may provide transport and related services to persons other than tourists, without prior notification to the Managing Agency, except as specified under conditions C4 and C6.
- C2 When conducting charter operations whilst transporting tourists or in conjunction with a tourist program, the Permit Holder may provide transport and related services to persons other than tourists in accordance with the vessel or aircraft operation conditions of this permit.
- C3 When providing transport and services to persons conducting activities in the Marine Parks which require the written permission of the Managing Agency, the Permit Holder must:
 - (i) not operate under this permit unless those persons have been granted the appropriate Marine Parks permit; and
 - (ii) only conduct operations in accordance with the conditions of that permit.

WITH NOTIFICATION

- C4 When conducting transport and related services to persons other than tourists using a vessel or aircraft, the Permit Holder must only access intertidal areas in accordance with the vessel operation conditions or aircraft operation conditions of this permit, unless otherwise approved in writing by the Managing Agency.
- C5 When providing transport and services to persons conducting activities in the Marine Parks which require notification to the Great Barrier Reef Marine Park Authority under Part 5 of the *Great Barrier Reef Marine Park Zoning Plan 2003* (Cth) and/or Part 4 of the *Marine Parks (Great Barrier Reef Coast) Zoning Plan 2004* (Qld), the Permit Holder must:
 - (i) not operate under this permit unless those persons have notified the relevant Managing Agency of their intended activities; and
 - (ii) conduct operations in accordance with any directions imposed by the Managing Agency.
- C6 When conducting transport and related services to persons other than tourists, the Permit Holder must not access Preservation Zones and Special Management Areas in accordance with condition G2 unless:
 - (i) in the presence of an officer of the Managing Agency; or
 - (ii) with prior written approval of the Managing Agency.
- C7 The Permit Holder must not conduct charter operations under condition C6 while transporting tourists or in conjunction with a tourist program.



INTERPRETATION

This permit extends to all employees of the Permit Holder, and other persons acting on behalf of or at the direction of the Permit Holder, for the purposes specified in this permit.

This permit is not intended to extinguish any native title.

Terms which are defined in the Dictionary have the meanings respectively ascribed to them.

A reference to any legislation or legislative provision:

- (a) is a reference to that legislation or legislative provision as in force from time to time; and
- (b) includes any statutory modification, substitution or re-enactment of that legislation or legislative provision.

A reference to anything after the words "include" or "including" does not limit what else might be included.

A note or heading may be used to give assistance in interpreting conditions in case of ambiguity.

A reference to a date includes that date.

DICTIONARY

'Affected Persons' means the Permit Holder and other persons who are acting on behalf of, or with the approval or at the direction of, the Permit Holder or for whom the Permit Holder is otherwise legally responsible.

'aircraft' has the same meaning as in the <u>Great Barrier Reef Marine</u> <u>Park Act 1975 (Cth)</u>.

'Amalgamated Great Barrier Reef Section' has the same meaning as the 'Great Barrier Reef Marine Park – Amalgamated Great Barrier Reef Section' in the <u>Great Barrier Reef (Declaration of Amalgamated</u> <u>Marine Park Area) Proclamation 2004 (Cth)</u>.

'ancillary vessel' means a small vessel which:

- (a) is not the primary vessel of the operation;
- (b) is only operated to provide services to the participants of the Permit Holder's operation; and
- (c) is only operated within three (3) nautical miles of the primary vessel.

'Appropriate Insurance' means the following insurances:

- (a) public liability for not less than \$20 million arising from any one
 (1) event in respect of the death of, or injury to, persons or loss or damage to property; and
- (b) under all applicable laws relating to workers' compensation to cover workers, eligible persons, self-employed contractors, directors, trustees and partners.

'Appropriate Insurer' means an insurer that is:

- (a) registered with the Australian Prudential Regulation Authority and have a Standard and Poor's (S&P) credit rating of no less than A-; or
- (b) a non-Australian insurer with a S&P rating of no less than A-; or
- (c) another insurer with the written approval of the Managing Agency.

'approved Certification Scheme' means a certification scheme approved by the Great Barrier Reef Marine Park Authority for the certification, to an appropriate level, of tourism-related products (including activities and associated facilities).

'aquatic devices' means motorised equipment which assists snorkelling and SCUBA diving activities, including motorised swimming aids (e.g. seabobs, diver propulsion vehicles) and underwater ride-on scooters (e.g. scubabobs, hydrobobs).

'Australian Prudential Regulation Authority' means a statutory body created under the <u>Insurance Act 1973 (Cth)</u> to regulate members of the finance, insurance and superannuation industry.

'Authority' means an authority granted in accordance with conditions G4 to G6.

'Byfield Area' for the Great Barrier Reef Coast Marine Park means those areas enclosed within the outer boundaries of the 'Planning Area' as defined in the Byfield Area Management Plan (2010), State of Queensland (Department of Environment and Science).

'Cairns Area Plan of Management' means the <u>Cairns Area Plan of</u> <u>Management 1998 (Cth)</u>.

'Cairns Planning Area' has the same meaning as in the <u>Cairns Area</u> <u>Plan of Management 1998 (Cth)</u>.

'Cairns/Cooktown Management Areas' means the geographical area defined by the Cairns/Cooktown Management Area of the Amalgamated Great Barrier Reef Section and the Cairns/Cooktown Management Area of the Great Barrier Reef Coast Marine Park.

'Cairns/Cooktown Management Area of the Amalgamated Great Barrier Section' means that part of the Amalgamated Great Barrier Reef Section that lies:

South of a line commencing at 14° 18.181' South, 144° 39.064' East, then running south-westerly along the geodesic to its intersection with the mainland coastline at 14° 39.909' South, 144° 56.564' East; and North of a line commencing at 17° 40.409' South 147° 17.013' East then running progressively:

- 1. south-westerly along the geodesic to 17° 52.809' South 146° 30.064' East
- 2. west along the parallel to its intersection with the mainland coastline at 17° 52.810' South 146° 06.269' East.

'Cairns/Cooktown Management Area of the Great Barrier Reef Coast Marine Park' means the area defined in Schedule 2, Part 4 of the <u>Marine Parks (Declaration) Regulation 2006 (Qld)</u>.

'Cairns/Cooktown Seasonal Gamefishing Area' is described at Attachment B.

'Claim' means a claim, action, suit, liability or demand of any kind for legal, equitable or administrative relief of any kind including for loss, damage, personal injury, death and associated costs and expenses.

'Claim Event' means an event or occurrence actually or potentially giving rise to a Claim.

'Conservation Park Zone':

- (a) in relation to the Great Barrier Reef Marine Park, has the same meaning as in the <u>Great Barrier Reef Marine Park Zoning Plan</u> <u>2003 (Cth)</u>; and
- (b) in relation to the Great Barrier Reef Coast Marine Park, has the same meaning as in the <u>Marine Parks (Great Barrier Reef</u> <u>Coast) Zoning Plan 2004 (Qld)</u>.

'craftless operation' has the same meaning as in the <u>Cairns Area</u> <u>Plan of Management 1998 (Cth)</u>, <u>Hinchinbrook Plan of Management</u> <u>2004 (Cth)</u> or <u>Whitsundays Plan of Management 1998 (Cth)</u> as the context permits.

'environment' has the same meaning as in the <u>Great Barrier Reef</u> <u>Marine Park Act 1975 (Cth)</u>.

'equipment' includes non-motorised vessels (e.g. kayak, paddleboard, windsurfer) and/or motorised vessels less than six (6) metres in overall length, (e.g. dinghy, personal watercraft).

'Estuarine Conservation Zone' has the same meaning as in the Marine Parks (Great Barrier Reef Coast) Zoning Plan 2004 (Qld).

'Far Northern Management Areas' means the geographical area defined by the Far Northern Management Area of the Amalgamated Great Barrier Reef Section and the Far Northern Management Area of the Great Barrier Reef Coast Marine Park.

'Far Northern Management Area of the Amalgamated Great Barrier Reef Section' means that part of the Amalgamated Great Barrier Reef Section that lies north of a line commencing at 14° 18.181' South, 144° 39.064' East, then running south-westerly along the geodesic to its intersection with the mainland coastline at 14° 39.909' South, 144° 56.564' East.

'Far Northern Management Area of the Great Barrier Reef Coast Marine Park' means the area defined in Schedule 2, Part 5 of the <u>Marine Parks (Declaration) Regulation 2006 (Qld)</u>.

'Fitzroy Marine Management Area' means all areas of the Great Barrier Reef Coast Marine Park (State) within the boundaries of:

- (a) the 500m coastal line around Fitzroy Island and Little Fitzroy Island; and
 (b) the leaders of the maximum part of the maximum files.
- (b) the landward boundary of the marine park surrounding Fitzroy Island and Little Fitzroy Island.

'General Use Zone':

- (a) in relation to the Great Barrier Reef Marine Park, has the same meaning as in the <u>Great Barrier Reef Marine Park Zoning Plan</u> <u>2003 (Cth);</u> and
- (b) in relation to the Great Barrier Reef Coast Marine Park, has the same meaning as in the <u>Marine Parks (Great Barrier Reef</u> <u>Coast) Zoning Plan 2004 (Qld)</u>.

'guided interpretive tour' has the same meaning as the 'guided interpretive tour (including fishing) operation' in the <u>Hinchinbrook Plan</u> of <u>Management 2004 (Cth)</u>.

'Habitat Protection Zone':

- (a) in relation to the Great Barrier Reef Marine Park, has the same meaning as in the <u>Great Barrier Reef Marine Park Zoning Plan</u> <u>2003 (Cth)</u>; and
- (b) in relation to the Great Barrier Reef Coast Marine Park, has the same meaning as in the <u>Marine Parks (Great Barrier Reef</u> <u>Coast) Zoning Plan 2004 (Qld).</u>

'harm' has the same meaning as in the <u>Great Barrier Reef Marine</u> <u>Park Act 1975 (Cth)</u>.

'Hinchinbrook Channel Location' means the areas shown in Attachment C and identified as The Haven/Scraggy Point Location, Hecate Point Location, Oyster Point Location, Cardwell Location, Dungeness Location, Eastern Hinchinbrook Channel Location and Western Hinchinbrook Channel Location.

'Hinchinbrook Plan of Management' means the <u>Hinchinbrook Plan</u> of Management 2004 (Cth).

'Hinchinbrook Planning Area' has the same meaning as in the Hinchinbrook Plan of Management 2004 (Cth).

'incident' means an event within the knowledge of the Permit Holder involving actual or potential harm to the ecosystem in the Marine Parks, including but not limited to:

- (a) coral damage; or
- (b) cyclone damage; or
- (c) any shipping event that requires notification to a relevant authority under the <u>Transport Operations (Marine Safety) Act</u> <u>1994 (Qld), Transport Operations (Marine Pollution) Act 1995</u> (Qld) or the <u>Navigation Act 2012 (Cth)</u>; or
- (d) any aircraft event that requires notification to the relevant Authority under the <u>Civil Aviation Act 1988 (Cth</u>); or
- (e) any discharge of untreated sewage effluent; or
- (f) any discharge of hazardous chemicals, fuel or biotoxic products.

'Indemnify' means indemnify and save harmless.

'Intensive Use Setting Locations' has the same meaning as in the <u>Hinchinbrook Plan of Management 2004 (Cth)</u>.

'intertidal area' means that area of the Great Barrier Reef Coast Marine Park between mean low water and the landward boundaries of the Great Barrier Reef Coast Marine Park.

'in the vicinity of' means:

- (a) for a specified bay, island or mainland, those waters and land between the high water mark on the coastline and a line every point of which is a distance of 1 kilometre seaward from that high water mark; or
- (b) for a specified reef, those waters and land enclosed by a line every point of which is a distance of 1 kilometre seaward from the edge of that reef; or
- (c) in relation to rivers, streams and inlets that part of those rivers, streams and inlets that are in the Great Barrier Reef Coast Marine Park.

'island' includes islands, islets, cays, rocks and sandbanks.

'Localities (Fitzroy Marine Management Area)'

The Fitzroy Marine Management Area is subdivided into four (4) localities by the following lines:

Boundary of Localities 1 and 2 — a straight line north west/south east through the points 16.922323° South, 145.98735° East and 16.92478314° South,145.99013460° East.

Boundary of Localities 2 and 3 — a straight line south from the 500m coastal line to Mean High Water Springs tide line (MHWS) on Little Fitzroy island at about 16.9215166° South, 146.0074° East then following the MHWS line to a point at about 16.9233° South, 146.0065° East, then south westerly to a point on Fitzroy Island at MHWS at about 16.92425° South, 146.0058666° East.

Boundary of Localities 3 and 4 — a straight line east/west through the points 16.93749371° South, 145.98265191° East and 16.9374931° South, 145.97799886° East.

Boundary of Localities 4 and 1— a straight line north west/south east through the points 16.93064569° South, 145.98046909° East and 16.93381900° South, 145.98376578° East.

'Mackay/Capricorn Management Areas' means the geographical area defined by the Mackay/Capricorn Management Area of the Amalgamated Great Barrier Reef Section and the Mackay/Capricorn Management Area of the Great Barrier Reef Coast Marine Park.

'Mackay/Capricorn Management Area of the Amalgamated Great Barrier Reef Section' means that part of the Amalgamated Great Barrier Reef Section that lies:

South of a line commencing at 19° 39.545' South, 150° 35.061' East then running progressively:

- 1. south-westerly along the geodesic to 20° 09.907' South 150° 20.061' East
- 2. southerly along the geodesic to 20° 29.907' South 150° 30.062' East
- 3. south-westerly along the geodesic to 20° 40.907' South 150° 10.063' East
- north-westerly along the geodesic to 20° 33.908' South 149° 07.063' East
- south-westerly along the geodesic to 20° 39.727' South 148° 45.813' East
- 6. west along the parallel to its intersection with the mainland coastline at 20° 39.727' South 148° 43.056' East.

'Mackay/Capricorn Management Area of the Great Barrier Reef Coast Marine Park' means the area defined in Schedule 2, Part 2 of the <u>Marine Parks (Declaration) Regulation 2006 (Qld)</u>.

'Managing Agency' means:

- (a) in relation to the Great Barrier Reef Marine Park, the Great Barrier Reef Marine Park Authority, a member of the staff of that Authority or a person referred to in Section 48A of the <u>Great</u> <u>Barrier Reef Marine Park Act 1975 (Cth</u>) performing functions or exercising powers under that Act in accordance with an agreement referred to in that section; and
- (b) in relation to the Great Barrier Reef Coast Marine Park, the Chief Executive of the Department of Environment and Science, his/her Delegate, an officer of the Queensland Parks and Wildlife Service, or a person referred to in section 52 of the <u>Marine Parks</u> <u>Act 2004 (Qld)</u>, appointed as an inspector.

'manner similar to a motorised water sport' means irregular driving otherwise than in a straight line (except for necessary turns or diversions), including:

- (a) driving in a circle or other pattern; or
- (b) weaving or diverting; or
- surfing down, or jumping over or across, any wave, swell or wash.

'Marine National Park Zone':

- (a) in relation to the Great Barrier Reef Marine Park, has the same meaning as in the <u>Great Barrier Reef Marine Park Zoning Plan</u> <u>2003 (Cth)</u>; and
- (b) in relation to the Great Barrier Reef Coast Marine Park, has the same meaning as in the <u>Marine Parks (Great Barrier Reef</u> <u>Coast) Zoning Plan 2004 (Qld)</u>.

'Marine Parks' means:

- (a) the Great Barrier Reef Marine Park established by the <u>Great</u> <u>Barrier Reef Marine Park Act 1975 (Cth);</u> and
- (b) the Great Barrier Reef Coast Marine Park established pursuant to the <u>Marine Parks Act 2004 (Qld)</u>.

'Marine Parks regulations' means:

- (a) in relation to the Great Barrier Reef Marine Park, the <u>Great</u> <u>Barrier Reef Marine Park Regulations 2019 (Cth)</u>; and
- (b) in relation to the Great Barrier Reef Coast Marine Park, the <u>Marine Parks Regulation 2017 (Qld)</u>.

'marine product' has the same meaning as in the <u>Great Barrier Reef</u> Marine Park Zoning Plan 2003 (Cth).

'Maritime Cultural Heritage Special Management Area' has the same meaning as in the <u>Great Barrier Reef Marine Park Regulations</u> 2019 (Cth).

'motorised water sports' has the same meaning as the 'motorised water sport' in the <u>Great Barrier Reef Marine Park Regulations 2019</u> (Cth).

'non-motorised water sports' means activities requiring nonmotorised craft (e.g. paddleboats, waterbikes, windsurfers) which are not for separate hire.

'overall length' has the same meaning as in the Great Barrier Reef Act 1975 (Cth)

'Pancake Creek' means the part of Pancake Creek that is within the Great Barrier Reef Coast Marine Park and upstream of the line worked out by reference to the following points-(a) latitude 24°01.278' south, longitude 151°44.628' east; (b) latitude 24°01.368' south, longitude 151°43.836' east.

Note— The line worked out by reference to latitude 24°01.278' south, longitude 151°44.628' east and latitude 24°01.368' south, longitude 151°43.836' east crosses the mouth of Pancake Creek at high water.

'passenger transport' means the transport of persons who are tourists into, out of or within the Marine Park, in order that those persons may engage in tourism activities in the Marine Park.

'passenger transport operation (Hinchinbrook)' has the same meaning as in the Hinchinbrook Plan of Management 2004 (Cth).

'permit' means the permission(s) the subject of Permit Number PERMIT NUMBER, and the associated conditions, granted to the Permit Holder pursuant to the Great Barrier Reef Marine Park Regulations 2019 (Cth) and the Marine Parks Regulation 2017 (Qld) as set out in this document.

'permitted activities' means the activities permitted by the conditions of this permit.

'permitted use' includes the activities contemplated by the permitted use.

'person' includes a natural person, a body corporate, a company or an incorporated association.

'personal watercraft' has the same meaning as in the Great Barrier Reef Marine Park Regulations 2019 (Cth).

'pest' means any animal, plant, parasite or disease causing organism (such as bacteria, virus or fungus) capable of causing adverse impacts to environmental, economic or social values whether or not it is

- (a) contributing to a Listed Key Threatening Process under the Environment Protection and Biodiversity Conservation Act 1999 (Cth); or
- prohibited or restricted under the Biosecurity Act 2014 (Qld) (b)

'photography, filming and sound recording' means low impact recording as defined in the Great Barrier Reef Marine Park Authority Activity Assessment – Photography, filming and sound recording Guidelines (Cth).

'Planning Area' means:

the Cairns Planning Area; (a)

- the Hinchinbrook Planning Area; and (b)
- the Whitsunday Planning Area. (c)

'Planning Area location' means an area defined as a Location in the Cairns Area Plan of Management, the Hinchinbrook Plan of Management or the Whitsundays Plan of Management

'Plan of Management' means a plan of management, as in force from time to time, that is prepared for the Marine Park in accordance with Part VB of the Great Barrier Reef Marine Park Act 1975 (Cth).

'Preservation Zone':

- in relation to the Great Barrier Reef Marine Park, has the same (a) meaning as in the Great Barrier Reef Marine Park Zoning Plan 2003 (Cth): and
- (b) in relation to the Great Barrier Reef Coast Marine Park, has the same meaning as in the Marine Parks (Great Barrier Reef Coast) Zoning Plan 2004 (Qld).

'taking' an animal, plant or marine product has the same meaning as in the Great Barrier Reef Marine Park Zoning Plan 2003 (Cth)

'Tongue Point' means the named peninsula on Whitsunday Island commencing north-east of the intersecting vectors of latitude 20° 16'S and longitude 149° 01'E.

'Townsville/Whitsunday Management Areas' means the geographical area defined by the Townsville/Whitsunday Management Area of the Amalgamated Great Barrier Reef Section, and the Townsville/Whitsunday Management Area of the Great Barrier Reef Coast Marine Park.

'Townsville/Whitsunday Management Area of the Amalgamated Great Barrier Reef Section' means that part of the Amalgamated Great Barrier Reef Section that lies:

- south-westerly along the geodesic to 20° 39.727' South 148° 45.813' East 5.
- 6. west along the parallel to its intersection with the mainland coastline at 20° 39.727' South 148° 43.056' East.

'Townsville/Whitsunday Management Area of the Great Barrier Reef Coast Marine Park' means the area defined in Schedule 2, Part 3 of the Marine Parks (Declaration) Regulation 2006 (QId).

'transiting' has the same meaning as in the Great Barrier Reef Marine Park Regulations 2019 (Cth)

vessel' has the same meaning as in the Great Barrier Reef Marine Park Act 1975 (Cth).

'visit' in relation to:

- a vessel (including the use of an ancillary vessel) means (a) accessing a permitted location, without departure, for a period not exceeding 24 hours; or
- an aircraft means one landing and one take-off at a permitted (b) location.

'waters adjacent to' in relation to a reef, means the waters enclosed by 'the 500 metre line' and in relation to an island or the mainland, the waters enclosed by 'the coastal 500 metre line' (as defined by the zoning plan or Marine Park regulation that applies to those waters).

'whale watching activity' has the same meaning as in the Great Barrier Reef Marine Park Regulations 2019 (Cth)

'Whitsundays Plan of Management' means the Whitsundays Plan of Management 1998 (Cth)

'Whitsunday Planning Area' has the same meaning as in the Whitsundays Plan of Management 1998 (Cth).

'year' means a period of 365 consecutive days except in the Whitsunday Planning Area where it means a calendar year (1 January - 31 December).

'Zone':

- in relation to the Great Barrier Reef Marine Park, has the same (a) meaning as in the Great Barrier Reef Marine Park Act 1975 (Cth); and
- in relation to the Great Barrier Reef Coast Marine Park, has the (b) same meaning as in the Marine Parks Act 2004 (Qld).

'Zoning Plan' means:

- in relation to the Great Barrier Reef Marine Park, the Great (a) Barrier Reef Marine Park Zoning Plan 2003 (Cth); and
- in relation to the Great Barrier Reef Coast Marine Park, the (b) Marine Parks (Great Barrier Reef Coast) Zoning Plan 2004 (Qld).
