The Great Barrier Reef Marine Park Authority has developed the Cairns Area Plan of Management to protect the values of the Area while maintaining a range of use opportunities.

HOW THE PLAN AFFECTS YOU


The Cairns Section Zoning Plan still applies to the whole of the Cairns Section of the Great Barrier Reef Marine Park, including the Area covered by this Plan of Management (refer to map on page 2). The provisions outlined in this booklet apply to all users of the Area. The reader should refer to the Plan of Management for more detailed information.

General Requirements applying in the Plan of Management Area

- No anchoring within 50 metres of moorings or 200 metres of a pontoon.
- No anchoring on coral in National Park Zones (dark green), Buffer Zones (light green) or Conservation Park Zones (yellow). Refer to the Cairns Section Zoning Map for details of these zones.
- Access to reefs will be subject to group and vessel size limits (refer to 'Requirements – Reef by Reef' section).
- More detailed management has been developed to protect attributes at specific locations (refer to 'Detailed Management for Specific Locations' section).



Detailed Management Provisions for Specific Locations

More detailed management has been developed to protect the attributes at Michaelmas Cay, Lizard Island, Low Island, Cod Hole and Green Island Reef Localities and the Frankland Island Sector. These management provisions are outlined in the following pages of maps.




Michaelmas Cay Locality

- Maximum group size of 15 people per vessel (including crew)
- Maximum vessel size of 20 metres
- Vessel speed limit of 6 knots No anchoring on coral in National Park Zones, Buffer Zones or Conservation Park Zones
- No anchoring within 50 metres of moorings
- No motorised watersports or hovercraft
- No operation of horns, loud speakers or sirens
- No pontoons allowed

- Maximum of 23 private moorings in the Michaelmas Cay Locality and a maximum of 2 private moorings for the remainder of the reef ie. within 500 metres seaward of the reef edge
- reef edge
 Aircraft must not enter within 3000 feet above the locality
- A maximum of 2 vessels per day for commercial tourist operations may be allowed access in addition to moorings-based operators


NB: Some existing tourist operations may be granted exemptions to group size, frequency and vessel size restrictions.



Frankiand islands Sector

- Maximum group size of 15 people per vessel No anchoring within 50 metres of moorings (including crew) within 500 metres of each reef edge
- Maximum vessel size of 20 metres within 500 . No motorised watersports or hovercraft metres of each reef edge
- Vessel speed limit of 6 knots within 150 metres of coast of each island
- No anchoring on coral in National Park Zones, Buffer Zones or Conservation Park Zones
- Aircraft must not enter within 3000 feet above the sector
- No pontoons allowed
- A maximum of I vessel per day for commercial tourist operations may be allowed access in addition to mooringsbased operators


NB: Some existing formst operations may be granted exemptions to group size, frequency and vessel size restrictions.



Cod Hole Locality

- Maximum vessel size of 35 metres
- No anchoring allowed, access for vessels via No inotorised watersports or hovercraft moorings only
- Maximum group size of 60 people per vessel No mooring of vessels for more than 4 hours in any period of 24 hours to public moorings

 - No pontoons
 - Maximum of 2 private moorings NB: Some existing tourist operations may be granted exemptions to group size, frequency and vessel size restrictions.



Lizard Island Locality 1

- Maximum group size of 15 people per vessel (including crew)
 - Maximum vessel size of 7 metres
- No mooring of vessels for more than 4 hours in No motorised watersports or hovercraft any period of 24 hours to public moorings
- No motorised watersports or hovercraft
- No private moorings
- No fishing (except trolling for the pelagics or bait netting for pelagics) inshore of the coastal 150 metre line, except as part of a permitted research program

Lizard Island Locality 2

- No limit on group size or vessel size
- No anchoring within 50 metres of moorings Motorised watersports are allowed
- No limit on private moorings

Lizard island Locality 3


- No limit on group sizes
- Maximum vessel size of 35 metres if anchoring
- No anchoring within 50 metres of moorings

Lizard Island Locality 4

- Maximum group size of 15 people per vessel (including crew)
- Maximum vessel size of 20 metres
- No motorised watersports or hovercraft
- No private moorings

Lizard island (Localities 1, 2, 3 & 4)

- No anchoring on coral in National Park Zones, Buffer Zones or Conservation Park Zones
- No pontoons NB: Some existing tourist operations may be granted exemptions to group size, frequency and vessel size restrictions.



Low Island Locality


- Maximum group size of 15 people per vessel Maximum of 1 pontoon (including crew)
- Maximum vessel length of 20 metres
- Vessel speed limit of 6 knots
- No anchoring on coral in National Park Zones, Buffer Zones or Conservation Park Zones

- No anchoring within 50 metres of moorings
 No anchoring within 200 metres of pontoons
 No island access between 6.00pm and 8.00am
- No waste discharge
- No motorised watersports or hovercraft

- Maximum of 5 private moorings for the locality and 5 private moorings for the remainder of the reef ie. within 500 metres of reef edge
- A maximum of 2 vessels per day for commercial tourist operations may be allowed access in addition to moorings-based operators

NB: Some existing tourist operations may be granted exemptions to group size, frequency and vessel size





Green Island Reef Locality 1

- Maximum group size of 60 people per vessel (including crew)
- Maximum vessel size of 35 metres if anchoring
- Vessel speed limit of 6 knots
- No anchoring within 50 metres of moorings
- No waste discharge
- No limit on private moorings

Green Island Reef Locality 2

- Maximum group size of 60 people per vessel (including crew)
- Maximum vessel length of 35 metres if anchoring No motorised watersports or hovercraft
- No anchoring within 50 metres of moorings

Green Island Reef Locality 3

- Maximum group size of 15 people per vessel (including crew)
- Maximum vessel size of 20 metres
- No private moorings

Creen Island Reef (Localities 1, 2 & 3)

- A maximum of 4 vessels per day for commercial tourist operations may be allowed access in addition to moorings-based operators
- No anchoring on coral in National Park Zones, Buffer Zones or Conservation Park Zones
- No pontoons NB: Some existing tourist operations may be granted exemptions to group size, frequency and vessel size restrictions.
