# **GBRMPA** roundup

Welcome to the first new look e-edition of *From the Deck*.

In 2008 the Great Barrier Reef Marine Park Authority (GBRMPA) took further steps to ensure tourism in the Marine Park is sustainable. This was done in a partnership with the Marine Park tourism industry.

Our continuing commitment to work in a sustainable way has included:

- piloting Ecotourism Australia's Climate Action Certification Program
- trialling the Emissions Calculator to help operators reduce their carbon footprint
- expanding the Sightings Network
- new moorings compliance work along the coast.

A Great Barrier Reef Marine Park and Other Legislation Amendment Bill 2008 was introduced into parliament in the middle of the year. The Bill was debated in the Senate in November where an amendment was made that provides for a tourism representative to be included on the GBRMPA Board. The amendment read, "at least one member must have knowledge of or experience in the tourism industry associated with the Marine Park".

The Bill was given Royal Assent on 25 November 2008 and its provisions are likely to take place in 2009.

The restructuring of the GRBMPA was finalised in November. As was reported in the last edition Andrew Skeat is the General Manager of our branch, Marine Park Management, which includes Field Management, Regional Engagement and Planning, and Environmental Assessment and Management.

Christina Sinnemann joined the Tourism and Recreation Section, in the role of



Climate Change Manager. The GBRMPA looks forward to welcoming back Lisha Mulqueeny as Director of Tourism and Recreation on 2 January.

## Take action on climate change!

The Climate Action Certification Program is a new certification scheme that recognises tourism operators' efforts to reduce carbon emissions and helps businesses plan for climate change into the future.

Launched by Ecotourism Australia at the Conference on Green Travel, Climate Change and Ecotourism in November, the program was jointly funded by the Great Barrier Reef Marine Park Authority and the South Australian Tourism Commission.

The program can be undertaken as a stand-alone certification process, or if operators are already EcoCertified, they only need to complete the additional work sections. The logo illustrated here will be awarded to an Advanced EcoCertified operator who achieved the Climate Action Business level under the Climate Action Certification Program.

Three levels of certification are available: Climate Action Business, Climate Action Innovator and Climate Action Leader, reflecting the performance of the operator in a number of climate change areas such as emission reduction. Fifteen Great Barrier Reef tourism operators trialled the program and eight operators have achieved certification so far:

## Moorings permit update!

To assist in the management of private moorings in the Marine Park, mooring permittees will be required to provide an approved drawing, compliance certificate, mooring reference number and location for each mooring when renewing or transferring their mooring permit. This requirement will come into force on 1 February 2009.

# Low Island gets low on carbon

Low Island is now one of the only islands in the world to be over 95% powered by renewable energies.

The GBRMPA's Commonwealth Islands Program helped the island deliver on the triple bottom line through:

 Solar panels: the island moved from 100% fossil fuel supply to 97% renewable supply, through solar panels and recycled bio-diesel

generators. The remaining 3% is gas used for cooking.

- Water tanks: enough were installed to ensure the island and its residents are provided with adequate rainwater during the drier months.
- Upgrade of the **sewerage treatment plant** to reduce its energy requirements.
- The involvement of **local suppliers**, with the double benefit of using local knowledge of tropical environments, and building capacity to deliver future sustainability

outcomes in the Great Barrier Reef and its communities.

Lessons learned from Low Island's journey towards sustainability are now being used on other Commonwealth GBR islands such as Lady Elliott. Tourism operators are encouraged to follow Low Island's sustainable example – it also all makes great financial sense!

# Sharks in pink, green and blue

New research results show that shark numbers in "blue" Habitat Protection Zones are heavily depleted compared to numbers at more protected reefs in "green" Marine National Park and "pink" Preservation Zones.

Results also revealed densities of whitetip and grey reef sharks were twice as abundant in pink zones as in green zones. These results stress the need for effective compliance in green zones, as sharks are particularly vulnerable to low levels of illegal fishing due to their conservative life-history characteristics (e.g. slow growth and reproduction rates).

# **Going Green**

Reef cruise operator Quicksilver Cruises is making a substantial investment in terms of sustainable practices. Its flagship 45m catamaran Quicksilver VIII was recently refitted with four MTU 2000 series diesel engines, providing a 40% weight reduction from the previous engines and an impressive reduction of carbon emissions by 20%.

Tony Baker, Managing Director of the Quicksilver Group, said: "At a cost of \$3 million, the refit and new engines were a considerable investment. With significant advances in technology, the choice of these engines ensures we will continue to deliver the 'best practice' we strive for as a company. They will also allow us to reduce our carbon emissions by about 20%, reinforcing our commitment to the environment and sustainability".
